Hon. Deputy Speaker: The Chairperson, Sectoral Committee on Labor, Social Welfare. Hon. Wanyoike, Vice Chair.


Hon. Peter Wanyoike: Thank you Mr. Speaker. I beg that this Assembly adopts the report of the Sectoral committee on Labor and Social Welfare on the retreat held at Sawela Lodge, Naivasha from 9th to 12th November 2016.

Mr. Speaker, following the sight visit of County sport facilities, the Committee resolved to go for a retreat to write a report regarding the status of the following sports facilities;

- 1. Kibera Sports Club
- 2. Joseph Kang'ethe Ground
- 3. Reruta Ground
- 4. Kangemi Ground
- Kaloleni
- 6. Uhuru Sports Ground
- 7. Dandora Phase 4 Sports Ground
- 8. Tena Ground
- 9. Jericho Ground
- 10. Huruma Ground
- 11. Korogocho Ground
- 12. Ziwani
- 13. California
- 14. Hamza Ground

The same visit had been conducted on 25th, 26th February and 2nd March 2015. Mr. Speaker, the objective of the site visit was to assess the status of the sports ground and facilities, their development against the previous allocation budget and to give recommendation and the way forward from the findings. Mr. Speaker, this report will go a long way in addressing the issues affecting County sports facilities and as such, I urge this House to adopt this report. Mr. Speaker sir, following the Committee findings and oral submissions by the stadia management officers who had accompanied the Committee, the flowing recommendations were raised. That:

a) The Committee be facilitated to develop a legislation that will address the challenges, that is, the County Sports Management Bill which will establish a Sports Management Bill that will oversee the operations of all the activities and links the County together with the Sports



Committee of at least five members who will be managing the facility operations on the ground but answerable to the Board;

- b) The task force be formed to carry out a thorough audit of the facility to determine their ownership and original demarcation, investigation on the development against budget allocation together with the stakeholders view; and
- c) The Executive to ensure that the facilities be fenced and security lighting and shades be installed.

Mr. Speaker I call upon Hon. Asha to second.

Hon. Asha Sosso: Thank you Mr. Speaker sir. Before I support this Motion I have some reservations to make.

Hon. Deputy Speaker: Hon. Member you are out of order.

Hon. Asha Sosso: Okay thank you.

Hon. Deputy Speaker: You first of all second or decline to second the Motion. But you can't say that you give the reservations first. So you either second first then you give out the reservations.

Hon. Asha Sosso: Mr. Speaker I am going to second this Motion ---

Hon. Deputy Speaker: Hon. Member you can't put conditions. If you have reasons to second the Motion, you second it and then you register your concerns.

Hon. Asha Sosso: I stand here to support the Motion. Is that okay Mr. Speaker?

Hon. Deputy Speaker: You are not in support of the Motion, you are seconding the Motion. Can you second the Motion?

Hon. Asha Sosso: I second the Motion.

Hon. Deputy Speaker: Thank you.

Hon. Asha Sosso: Can I make my reservations?

Hon. Deputy Speaker: You are free.

Hon. Asha Sosso: Mr. Speaker as the Labour Committee we have gone around these grounds and there are some grounds which have been looked into. I am asking the management to be keen on the ground of Woodley as far as I stay on those sides. That ground needs to be done because it is in a pathetic condition as we are talking. Thank you.
