THE NAIROBI CITY COUNTY POP UP MARKETS AND STREET VENDORS BILL, 2019 (ASSEMBLY BILL 9 OF 2019)

A Bill for an Act of County Assembly of Nairobi to create a legal framework for establishment, regulation and recognition of pop up markets and street vending in Nairobi County and for identification of minimum standards for pop markets and street vendors and for related purposes

THE NAIROBI CITY COUNTY TRANSPORT BILL 2019 (ASSEMBLY BILL 10 OF 2019)

A Bill for an Act of the County Assembly of Nairobi City County to provide for administration of county transport to make provisions for county roads, public road transport, traffic management, parking, street lighting and for connected purposes

COMMUNICATION FROM THE CHAIR

FAMILIARIZATION OF MEMBER WITH THE BUILDING BRIDGES INITIATIVE REPORT

Hon. Members, I have the following Communication to convey:

Hon. Members, as you may all be aware, the Building Bridges Initiative - BBI in Kenya was initiated on 9th March 2018 after H.E the President Uhuru Kenyatta and his closest competitor in the 2017 presidential election, H.E Raila Odinga, decided to shakes hands and unite the country that was at the brink of war. What is now commonly referred to as the Handshake in Kenya.

Subsequently Hon. Members, a team of individuals was thereafter formed who held public participation forums across the 47 counties in Kenya to collect views on what changes Kenyans would want to see from the provided 9 agendas, being:

- i. How to end ethnic division;
- ii. Inclusivity;
- iii. How to solve polarizing elections;
- iv. Safety and Security;
- v. How to deal with corruption;
- vi. How to deals with lack of national ethos;
- vii. Responsibility and rights
- viii. Shared prosperity; and,
- ix. Enhancing devolution

Hon. Members, it is also worth appreciating that the technical team launched its report containing recommendations and general suggestions for constitution amendments as contemplated in Article 257 of the Constitution of Kenya, 2010.

Hon. Members, whereas Article 257 (5) of the same provides that; "If the Independent Electoral and Boundaries Commission is satisfied that the initiative meets the requirements of this Article, the Commission shall submit the draft Bill to each county assembly for consideration within three months after the date it was submitted by the Commission." While in anticipation for the said, there is need for the Members of the Assembly to familiarize themselves with the Building Bridges Initiative Report for the interest of your electorates especially during the long recess.

Hon. Members, you will note with appreciation, the provision of Article 196 (1) of the Constitution of Kenya, 2010, which provides that the Assembly shall:

- (a) conduct its business in an open manner, and hold its sittings and those of its committees, in public; and
- (b) Facilitate public participation and involvement in the legislative and other business of the assembly and its committees.

As the people's representatives, it is prudent that when time come for you to exercise your legislative authority, you will be in a position to debate from an informed point of view.

CHANGE IN COMMITTEES LEADERSHIP

Hon. Members, the County Assembly Sectoral Committee on Transport and Public Works resolved to elect a new Chairperson of the Committee following a vote of no confidence in the former Chairperson, Hon. James Mwangi Wambui, MCA.

Consequently, Hon. Members, I wish to recognize the elections of Hon. Joyce Muthoni Kamau, MCA, as the new Chairperson of the Sectoral Committee on Transport and Public Works. I wish to thanks the former Chairperson of the Committee for leading the committee for the last two and a half years and request the new Chairperson to steer for the betterment of the County.

Additionally, Hon. Members, my office is aware of the resolution of Sectoral Committee on Planning and Housing on the vote of no confidence in its Chairperson.

Furthermore, the Leader of Majority Party has this afternoon tendered his resignation as the Chairperson of the Sectoral Committee on Trade, Tourism and Cooperatives.

Therefore, Hon. Members, I wish to direct that the members of the Sectorial Committee on Planning and Housing and Trade, Tourism and Cooperatives respectively to converge for a meeting of the election for their Chairperson in accordance with provisions of Standing in Order 171.

Hon. Members, I urge you to cooperate with your chairpersons in various Committees to ensure that you execute your mandates in the committees effectively for the betterment of the County Government.

REPORT OF THE AUDITOR GENERAL ON THE FINANCIAL STATEMENT OF NAIROBI CITY WATER SEWERAGE COMPANY LIMITED FOR THE YEAR ENDED 30 JUNE 2018
