Members are supposed to travel; some are travelling to committees and sports. Players must have time to practice and all members will travel to Eldoret as agreed. We also have several committees that are supposed to go to Mombasa. For us to cut costs, let the Chairman of Water transfer that committee sitting from Mombasa to Kisumu. Hon. Deputy Speaker: Hon. Otieno, you are supposed to move, why are you diverting the attention of members?

Sports event bring people together and this time around I am proud all of us are going. Also the Minority Leader is going to play. I hope if he comes back, he shall be as fit as a fiddle. Even the Speaker, I have never seen him in the field, he should come and jump then we make friends. I beg you call the mover to reply.

Hon. Joseph Ndonji: Thank you, Mr. Speaker. I rise to support the motion except the old ones like 'Mo fire' who should not enter the field. I tried last time and dislocated my leg. Hon. Deputy Speaker: Hon. Emilly Ondeje Oduor,

Hon. Emily Oduor: Thank you, Mr. Speaker and thank you for calling me with all my names. I can see you are doing a lot of justice to us. I would like to support this motion and at same time appeal to members to show up in Eldoret and cheer us up especially us the players. We go there as other teams have carried their cheering squads but for Nairobi we only have a few and after three days we have lost our voices.

Hon Jeremiah, the reason why sometimes we lose is because we don't have the cheering squad. We don't have the moral support. I appeal to the leadership to be there and support us. Hon. Deputy Speaker: Hon. Kennedy Omondi Obuya.

I rise to support the motion and I make a prayer that the Clerk's office would facilitate us since we are adjourning today. I have information that there are other committees travelling to Mombasa and others to Eldoret. Hon. Deputy Speaker: Thank you. Hon. Kennedy Odhiambo Oyugi.

Hon. Kennedy Oyugi: Thank you, Mr. Speaker. I rise to support as has been done by most members. I want to passionately appeal to the House Business Committee in regards to responses. In a number of occasions, the House Business Committee has slotted responses but when we come here---

Hon. Elias Otieno: Mr. Speaker, let those people go to Eldoret and if they do not attend and miss their per diem, then they should not blame anyone. I beg that you do not allow anyone to walk out the door because we have a very important business to transact. Thank you

THE NAIROBI CITY COUNTY APPROPRIATION BILL (ASSEMBLY BILL NO. 8 OF 2019)

Hon. Deputy Speaker: Chair, Budget?

Hon. Robert Mbatia: Mr. Speaker, I beg that the Nairobi City County Appropriation Bill, 2019, be read a second time.

Mr. Speaker, once in each year, the County Assembly is called upon to consider and approve the estimates of revenues and expenditure not only as a statutory duty but as gatekeepers of the county public purse.

Mr. Speaker, on Wednesday the 26th June 2019, this County Assembly approved the annual estimates for the Financial Year 2019/20 totaling to Kshs. 35.28 billion consisting of Kshs.24.29 billion for recurrent expenditure and Kshs. 10.99 billion for development expenditure. In the approved budget, the County Assembly had been granted a total resource envelope of Kshs. 3.2 billion consisting of Kshs.1.67 billion for recurrent and Kshs.1.53 billion for development expenditure. The approvals for votes under the county executive were meant to guarantee efficient delivery of services on critical areas of garbage collection, implementation WDF projects, rolling out disaster mitigating measures, settling of pending legal fees, purchase of vehicles for various sectors and making the county visible at the devolved unit among others.

Mr. Speaker, on the 27th June 2019, the county considered and approved a motion on vote account which granted the authority to the county government to withdraw from the county revenue funds amounts not exceeding Kshs. 8.7 billion made up in the manner set out on the vote of accounts schedule laid before the county Assembly. The approval granted was only meant for the purpose of meeting expenditure necessary to carry out the services of the Nairobi City County and the County Assembly during the financial year ending June 30th, 2020.

Mr. Speaker, the passage on the vote on account had been occasioned by the delay of the National Assembly and the Senate to agree on and pass the division of revenue bill and the count allocation of revenue

bill which are very critical legislations as they determine county equitable share of revenues conditional allocations and the recurrent ceilings for the County Assembly. Without these laws, the County Assembly will be engaging in guesswork if it purported to appropriate sums whereas amounts meant to fund more than half of the budget had not been agreed on.

Mr. Speaker, this was an important middle ground that granted the county departments authority to spend amount not exceeding Kshs. 8.7 billion or 25% of the amounts contained in the tabled estimates as required by provisions of section 134 (2) (b) of the PFM Act 2012. In this approval, there was no authority granted for expenditure on development activities.

Mr. Speaker, parliament having passed both the division of revenue bill and the county allocation of revenue bill, we have thus far been assented by His Excellency the President, the appropriation bill has therefore been submitted to provide legal basis for expenditure of amounts appropriated in the approved estimates for the financial year 2019/20. However, given that the estimates were approved before the above bills were passed by parliament, the figures contained therein especially on the revenue side of the budget are statistically different and the committee shall be recommending that the necessary adjustments be made on the approved budget.

Mr. Speaker, in summary, as I finalize the adjustments, the need to align the county budget to the changing circumstances arising from the late passage of the relevant legislations of vertical allocation of resources from the national exchequer, the bill has made a number of amendments to the approved budget of the financial year 2019/20.

Mr. Speaker, on the revenue side of the budget, members may recall that this County Assembly approved a total resource envelop of Kshs 35.28 billion consisting of 16.5 billion as equitable share of revenues Kshs. 767 million as conditional grants and Kshs 17.3 as internal resource allocation. However, following the approval of the county allocation revenue act (KARA), the allocation for equitable share is projected to fall by Kshs 580 million. KDSP to fall by Kshs 17.98 million and bank balances brought forward from the previous financial year standing at Kshs 1.88 billion. At the same time, the county did not receive Kshs. 415 meant for road maintenance for financial year 2018/19 due to non-fulfilment of conditions o that were given and the amounts have been included for use in the current financial year. Overall, therefore, the total revenues available are projected to increase by Kshs 1.68 billion compared to the approved budget for the financial year 2019/20.

On the expenditure side of the budget, the approved budget had projected that to meet the recurrent expenses for the county assembly, there would be a total resource requirement of Kshs 1.67 billion. However, the county allocation of revenue act has granted the County Assembly a total recurrent ceiling of Kshs. 1.4 billion being a deficit of Kshs 261 million. The bill has therefore rationalized downwards the allocation to the county Assembly by 261 million with part of the amount transferred to the County Executive demarcated to support legislative engagements between the two arms of the government.

Further, the budget has been rationalized under the salaries component by scrapping thereof the provision for collective bargaining agreement (CBA) which had originally been allocated Kshs 689 million. Recruitment for new employees' allocation reduced by Kshs 313 million. Allocation for other recurrent reduced by Kshs 2.8 billion to make provision of amounts owed to KRA as pending statutory deductions.

On development, there has been enhanced allocation of Kshs 298 million to cater for increased creditors at Kshs 268 million and appropriations in aid under polytechnics at Kshs 30.6 million.

Overall, the budget is expected to balance at Kshs 36.98 billion with Kshs 11.29 billion or 31% being earmarked for development activities.

- Mr. Speaker, in my recommendation, having reviewed the Appropriation Bill 2019, the committee recommends that the following adjustments be made in the approved budget for the financial year 2019/2020.
 - 1. That the adjustments on the overall budget be approved as in schedule 1;
 - 2. That in line with number 1 above, the recurrent budget for domestic travel for respective sectors be rationalized to provide indicated amounts for county executive to county assembly engagement as contained in schedule 2;
 - 3. That resources for engagement between finance, budget and appropriation and the county executive on budget matters be domiciled in the county treasury;
 - 4. That projects in schedule 3 attached to this report be approved and implemented in the financial year 2019/20.

Hon. Speaker, I beg to move this and request the Leader of Minority to second me. Thank you.

Hon. Elias Otieno: Mr. Speaker, if you check the list, I am no. 16. I don't know how he came up with no. 19. So, I beg to second.

(Question proposed)

Hon. Deputy Speaker: Mover.

Hon. Robert Mbatia: Thank you Mr. Speaker. I want to thank the entire Assembly and your office for the support that you have given us to get through this despite the short period. It is evident that the county is almost stalling to a halt because of the vote on account expenditures. This should be an indicator to the members of the Executive of the goodwill that we are extending to them. We are shortening the period. We are passing this bill and they should extend the same to us the goodwill that we are extending to them by rolling out the projects in our wards very fast. I also want to thank our budget office which has worked tirelessly to have this document in place.

Mr. Speaker, my humble request to your office is that, recently we have benchmarked with other counties and other countries and we have seen that for an assembly to be effective, especially the budget making in assemblies and parliaments, they must have a fully functional Budget office. So, I would request that this time round, we have a fully furnished, functional budget office. Thank you. I beg to reply.
