STATEMENTS

ALLEGED UNPROCEDURAL TOWING PRACTICES OF PRIVATE CARS BY COUNTY ENFORCEMENT OFFICERS

Hon. Daniel Muturi: Thank you Hon. Speaker. Hon. Speaker pursuant to Standing Order 45(2) (c) I wish to request for a statement from the Chairman of the Sectoral Committee on Transport and Public Works regarding alleged unprocedural towing practices of private cars by county enforcement officers using private break downs and recovery units in the county, especially in the central business district.

Hon. Speaker there has been allegations of existence of many private break down within the CBD, continuing to take advantage by overcharging motorists who park within the city which has been against the Nairobi City County Finance Act. These break down and recovery entities further damage private vehicles compelling the owners to incur unnecessary costs for repair works. Hon. Speaker, in the statement, the Chairperson should inquire into and report on: -

- 1. Reasons the county enforcement officers opt to chain and tow private vehicles that can otherwise be driven to county yards and failure by the said bread downs and recovery units to re-compensate the car owners for damages occurring in the course of the operations.
- 2. Whether there is an agreement between the County Government and Nairobi Metropolitan Service and private towing and recovery entities.
- 3. Measures the County Executive and NMS are putting in place to restore orderliness in the manner private vehicles are towed and/or are clamped.
- 4. Measures that the County has put in place to ensure that enforcement officers adhere to the towing fees as prescribed in the Finance Act

Hon Speaker if you gave me a bit of a leeway, there appears to be some kind of, if I may use the word 'cartels'. Hon Speaker, the way vehicles are towed, vehicles that can be driven, the manner in which people are pulled out of their cars is not only immoral Hon. Speaker, so I hope this can be looked into.

GROWING NUMBER OF PARKING BOYS AND STREET CHILDREN IN THE CENTRAL BUSINESS DISTRICT

Hon. Daniel Muturi: My second statement, Hon Speaker, pursuant to Standing Order 45(2) (c), I wish to request for a statement from the Chairperson of sectoral committee on Transport and Public Works regarding growing number of parking boys and street children in the central business district.

Hon. Speaker, there has been a concern on the mushrooming street families and parking boys within the CBD which have continued to pose security threats through extortion and robbery along popular restaurants in the city. Hon. Speaker, there is an alleged syndicate of parking boys operating in the morning and evening hours, who do not only vandalize private vehicles but also elicit gross disorderliness within the central business district and obstruct a tranquil environment for business to thrive seamlessly. Hon. Speaker in the statement the Chairperson should inquire into and report on: -

- 1. The completion status of rehabilitation center in Ruai that was intended to accommodate street families and give them opportunities for education among other opportunities; and
- 2. Measures the County Executive and Nairobi Metropolitan Services are putting in place to manage the increased number of parking boys and street families within the Central business district and restore sanity.

Hon. Speaker, there was a Motion which we did, if I may indulge you a bit, Hon Mbote brought a Motion on how to rehabilitate or how to deal with the street families, of which they are our children, our brothers and sisters. But Hon. Speaker, Nairobi CBD has become quite a hazardous place. People coming along for their businesses or to eateries such as CJ's restaurant on Koinange street, the Java's and offices, Hon. Speaker you park your car, if you don't part with a hundred shillings you find your car vandalized; my brother has experienced that; we have experience that, so this is not a makeup tale.

Hon Speaker, unless we restore sanity in the CBD and also take into consideration the Covid 19 pandemic which has taken businesses on a down turn, and now furthermore, people are not able to come and support the businesses- whether restaurants or other businesses- it is a high time we actually took charge and restore sanity. Some of these people, Hon. Speaker, other than the street families which I said are our children, our brothers and sisters; there are other people who come to work. They come at 9 a.m. and leave at 5 p.m., this means they have their homes, so this is not an issue of street families, there are people who are here to extort.

Hon. Speaker, I think if you read yesterday's Daily Nation, there was an article on the same, which actually is painting Nairobi County in a very bad light, and especially when it is the media, it stops tourism, domestic or otherwise. Thank you Hon. Speaker for your time.

Hon. Speaker: Thank you. Chairman Transport and Public Works, can you give an undertaking on how long you will be able to act on the two statements. Leader of Majority, respond.

Hon. Abdi Hassan: Mr. Speaker Sir, the committee will strive to give a response in three weeks' time. Thank you.

Hon. Speaker: Is it okay, Ngengi?

Hon. Daniel Muturi: Hon Speaker the Majority [Leader] has spoken, thank you.

Hon. Speaker: Hon Jeremiah Themendu, he has also a statement.

PROLONGED DELAY IN ISSUANCE OF TITLE DEED TO LAND OWNERS IN NAIROBI CITY COUNTY

Hon. Jeremiah Themendu: Thank you Hon. Speaker. Pursuant to Standing Order 45(2)(c), I wish to request for a statement from the Chairperson of the select committee on Planning and Housing regarding the prolonged delay in issuance of title deed to land owners in Nairobi City County.

Hon. Speaker, on 12th August 2020, H. E. The President issued over one thousand two hundred title deeds at Jacaranda Girls to residents of Kayole, Dandora, Mathare and Kariobangi estates among other neighborhoods in the city's Eastlands area.

Hon. Speaker, H. E. The President issued a directive that the said title deeds be issued free of charge. However, there have been complaints from the residents who are allegedly asked to pay Kshs. 30,000 each, purportedly for lawyers to process the title deeds before issuance to land owners contrary to the presidential directive.

Hon Speaker it is disturbing to note that even for a section of land owners who have gone forth to pay the said amount are yet to be issued with their title deeds. Hon. Speaker in the statement, the Chairperson should enquire into the report on: -

- 1. Reasons the County Executive is demanding for Kshs. 30,000 from each land owner against the Presidential directive that the title deeds be issued free of charge.
- 2. Reasons for the persistent delays in issuance of the title deeds even after payment of Kshs. 30,000 by a section of the residents and;
- 3. Measures being put in place by the County Executive and Nairobi Metropolitan Service to ensure that title deeds are issued to land owners and residents as intended.

Hon. Speaker, H.E. the President had a good intention and it was to empower Nairobians by giving them title deeds for free. Even if you see some land owners in Kayole Central building their houses using stones and ballast and whatever, it does not mean that they are rich and I think the issuance of the same has taken too long and I wish the Committee shall take it with the urgency it deserves. Thank you Hon. Speaker.

Hon. Speaker: Thank you. Chairman Planning and Housing, do give an undertaking or Leader of Majority.

Hon. Abdi Hassan: Mr. Speaker Sir, the committee will strive to give the response in three weeks' time. Thank you.

Hon. Speaker: I am made to understand that the Deputy Speaker has a personal statement to make. Proceed.

Hon. Speaker: Thank you Honorable Member. May I also take this opportunity to thank you for the time that you served this Assembly, and having made a decision on your own volition, it has been accepted and I also declare the office of the Deputy Speaker vacant.

I also want to put it in record that we will be conducting the election in our next sitting that is on Tuesday, morning hours. Thank you.
