COMMUNICATION FROM THE CHAIR

CONDUCT OF ASSEMBLY SITTINGS

As you can recall during today's morning sitting, I conveyed guidelines issued by the Head of Public Service regarding containment measures for the spread of Covid 19. Consequently, I conveyed a special meeting for the County Assembly Service Board to deliberate on how to implement the said guidelines.

Accordingly, Hon. Members, the County Assembly Service Board has adapted the following measures which should be strictly adhered to beginning Thursday 23rd July 2020 at 2.30 p.m. We shall be holding virtual sittings. Only the House leadership and the mover of a business on the floor shall be allowed in the Chamber. All the other members shall follow and participate in the assembly proceedings via zoom. The office of the Clerk is directed to facilitate the virtual sittings.

Visitors will not be allowed in the assembly precincts including in committees unless in exceptional circumstances. Members are also encouraged to stay away from the precincts. Members of the public are encouraged to send electronic mails. The Clerk shall be sharing documents with members and staff electronically. There will be a scale down of staff turning up for work. Adequate PPEs and sanitizers shall be provided by the Service Board.

Hon Members, these measures are aimed at protecting you and your loved ones from this dangerous virus. It is so directed.

NOTICES OF MOTION

GUIDELINES FOR APPROVAL BY THE COUNTY ASSEMBLY ON THE SECONDMENT AND/OR DEPLOYMENT OF OFFICERS

Hon. Moses Ogeto: Hon. Speaker, I beg to give notice of the following Motion:

THAT, aware that Article 187 of the Constitution, 2010 and Section 24 of the Intergovernmental Relations Act, 2012 provides for the transfer of functions and powers from one level of Government to another; further aware that on 25th February, 2020, the Governor signed a memorandum transferring some of the County Government functions such as health services, transport services, county planning and development services and public works to the National Government as provided for in the Constitution which took effect from 17th March, 2020 and for twenty-four (24) months subject to renewal; acknowledging that in execution of the Transfer Deed, His Excellence the President established the Nairobi Metropolitan Services Office to spearhead the implementation of the transferred functions; recognizing that there has been a rift between the County Executive and the Nairobi Metropolitan Services on various issues such as process of secondment and/or deployment of public officers from the County Executive to Nairobi Metropolitan Services; noting that Article 187 (2) (b) of the Constitution provides that constitutional responsibility for performance of the function or exercise of power on transferred functions shall remain with the government to which it is assigned by the Fourth Schedule, this Assembly urges the County Executive in conjunction with the Nairobi Metropolitan Services to develop guidelines for approval by the County Assembly on the secondment and/or deployment of officers from the County Government to the Nairobi Metropolitan Service to enhance seamless service delivery to the residents of Nairobi City County.

REQUEST FOR ALL NECESSARY DOCUMENTATION FROM CONTRACTORS ON EXISTING CONTRACTS

Hon. Samora Mwaura: Hon. Speaker, I beg to give notice of the following motion; That, Article 97 of the Constitution 2010 and Section 24 of the Intergovernmental Relations Act 2012 provides for the transfer of functions and powers from one level of government to another; Further aware that on 25th February 2020 the Governor entered a memorandum of transferring some of the functions such as Health Services, Transport Services and Public Works Services to the National Government as provided for in the Constitution which took effect from 17th March 2020 and for 24 months subject to renewal; Acknowledging that in the execution of the transfer deed H.E the President established the Nairobi Metropolitan Services Office to spearhead the implementation of the transferred functions.; Concerned that there is no lack of consensus between the County Executive and the Nairobi Metropolitan Services on the implementation of various projects which are under the transferred functions has brought amongst some contractors who had commenced works before the transfer of functions was effected as the County Executive is unwilling to hand over some of the capital projects which are under the transferred functions to the Nairobi Metropolitan

Services, this Assembly urges the Nairobi Metropolitan Services to request for all the necessary documentation from the contractors on the existing contracts on all capital projects which are under the transferred functions with a view of ensuring the contractors complete the projects in timely manner and avoid stalling of such projects. ESTABLISHMENT OF AN EMPLOYMENT INSURANCE FUND

Hon. Mbugua Kabiro: Thank you very much Madam Speaker. My motion subject is the establishment of an Employment Insurance Fund.

Hon Speaker I beg to give notice of the following motion; That Article 6 of the Constitution of Kenya 2010 provides for the two levels of government, the National and the County level which are distinct and inter-dependent and required to conduct their mutual relation on the basis of consultation and cooperation; Further aware that Article 41 of the Constitution provides for the right to fair labour practices including forming, joining or participating in activities and programmes of a trade union; acquainted that recent months have witnessed increased cases of job losses not only in Kenya but globally with an estimation of over 1 million jobs lost by June across all sectors in Kenya due to the corona virus pandemic; concerned that a majority of people in Nairobi had high hopes and ambitions in the beginning of the year; however, poor micro economic performance and lack of labour market opportunities and the current pandemic have resulted in reduced revenue, loss of business opportunities, loss of markets for goods and services, shortage of raw materials and the re-structuring due to the tough economic times; Noting that high expectations, disappointing employment and life prospects have fueled frustration and desperation among many people who have turned to criminal behavior, violence, substance abuse, commercial sex work and even suicide; Acknowledging that the National Government has developed several economic stimulus programs and measures to cushion the economy from the impact of the Covid 19 pandemic; this Assembly urges the County Executive to develop a policy to establish an employment insurance fund to which employers and employees contribute and from which employees who become unemployed or their beneficiaries, as the case may be, are entitled to benefit in order to alleviate the harmful economic and social effects of unemployment. RESPONSE TO A STATEMENT REGARDING DELAYED COMPLETION OF IMPORTANT PROJECTS IN THE COUNTY

Hon. Jared Akama: On Tuesday 16th June 2020 Hon. Redson Otieno, MCA, rose on the floor of the Assembly pursuant to Standing Order No. 45 (2) (c) and requested for a statement from the Chairperson Sectoral Committee on Water and Sanitation regarding delayed completion of important projects in the County.

In the Statement the Member requested that the Chairperson should inquire into and report on; -

 The measures put in place by the County Executive to have the toilet completed and opened for public use.

2. What steps the County Executive is taking to ensure that such facilities are adequate in the wards to enhance hygiene and sanitation.

Hon. Speaker, the committee wrote to the Executive Committee Member responsible for water and sanitation on 18th June 2020 requesting the CEC Member to furnish the Committee with the response to statement requested by the Member.

In this regard Hon. Speaker, I wish to report to the Assembly as follows: -

1. The Measures put in place by the County Executive to have the toilet completed and opened for public use:

Hon. Speaker the Committee was informed that the delay in completion of the project was occasioned by the inability to procure the material due to frustration of supply of important sanitation fitting because of the current COVID 19.

However, the Nairobi Water City Water and Sewerage Company have already secured requisite materials and have embarked on completion of the works.

2. What steps the County Executive is taking to ensure that such facilities are adequate in the wards to enhance hygiene and sanitation.

Hon. Speaker, the Committee was informed that the director has prioritized ablution block based on assessed needs and plans are underway to declare Mathare area including Ngei Ward a special planning area to enhance comprehensive water and sanitation services among others.

Hon. Redson Otieno was invited to the committee's virtual meeting and was satisfied with the response forwarded by the executive officer from the water sector. A copy of the detailed response has been given to the Hon Member who requested for statement and a further copy is hereby attached to this Report. Hon. Speaker, I beg to lay this response. Thank you.

Hon. Speaker: Thank you Chair, I know that Hon. Redson is not in the House but it is well if he has a copy.
