## NOMINEE FOR THE POSITION OF THE MEMBER OF THE NAIROBI CITY COUNTY PUBLIC SERVICE BOARD AND SECRETARY TO THE COUNTY PUBLIC SERVICE BOARD

Hon. Speaker: Hon. Members, we have a message from H. E the Governor.

Hon. Members, Standing Order 43 (1) relating to the messages from the Governor provides that the Speaker shall read to the County Assembly any message from the Governor or the Senator of the County delivered to the Speaker for communication to the Assembly. In this regard Hon. Members, I wish to report that the office of the Speaker is in receipt of a message from H.E the Governor of Nairobi City County on the following: -

- 1. Nomination to the position of the Board Secretary to the Nairobi Public Service Board; and
- 2. Nomination for the position of the Member of the Nairobi Public Service Board. I now wish to convey the following message:

Hon. Members you are aware Section 58(1)(b) and Section 58(1) (c) of the County Government Act 2020 provides for the nomination and appointment of a Member and Secretary to the County Public Service Board respectively, with the approval of the County Assembly from among persons who are not Members of the County Assembly through a competitive process.

Hon. Members, pursuant to the provisions of section 58(1)(b) and section 58(1) (c) of the County Government Act, H. E the Governor hereby nominates Jack Babji Owino to the position of Member to the County Public Service Board and Phillip Polland George Kaingu to the position of Secretary to the County Public Service Board. Hon. Members I wish to direct the Sectoral Committee on Labour and Social Welfare proceed with the vetting of the said nominees. Thank you.

#### NOTICES OF MOTION

**Hon. Moses Ogeto**: Thank you Hon. Speaker. Once again, good morning. Hon. Speaker I want to give a Notice of Motion.

That aware Part 2 of the Fourth Schedule of the Constitution of the Republic of Kenya 2010, the functions and powers of the County Government among others covers the public health. Further aware section 118(b) of the Public Health Act, Cap 242, identifies nuisance and any dwelling of premises or part of construction as such as dirty to be dangerous to health; noting that Nairobi City County is an entry point into the country by international guests. Further noting that the aesthetic characteristics of the city gives the first impression of its general organization and national character. Cognizant that the Nairobi County Government and Nairobi Metropolitan Services have separately issued public notices to the owners of the building to repaint in line with Nairobi County City Beautification Initiative. Concerned that to large extent, the property owners have ignored to comply with the said notices. Realizing that the County has a responsibility to make laws and policies in people's interest, which will hold in trust, this Assembly resolves that the County Executive and Nairobi Metropolitan Services moves with speed to enforce their aforementioned notices on repainting of buildings in the City. ## STATEMENTS

# REQUEST FOR STATEMENT REGARDING BLATANT NEGLIGENCE OF AN EXPECTANT MOTHER IN PUMWANI MATERNITY HOSPITAL

**Hon. Doris Kanario**: Thank you Mr. Speaker Sir. First and foremost, I wish to congratulate you on your appointment as our Speaker in this Assembly at this time.

Hon. Speaker, Pursuant to Standing Order 42(c) I wish to request for a statement from Chairperson of the Sectoral Committee on Health Services regarding blatant negligence of an expectant mother in Pumwani Maternity Hospital.

Hon. Speaker the right to health is a fundamental human right, guaranteed in the Constitution of Kenya 2010, Article 43(1)(a) which provides that every person has a right to the highest attainable standard of health which includes the right to health care services including reproductive health care.

Hon. Speaker a few days ago a video clip of a woman in labour lying on the tarmac outside Pumwani Maternity Hospital has been all over the social media. This is not only alarming, outrageous; on the sorry state of the county hospitals, but also leaves much to be desired in terms of provision of basic health care services to the residents of Nairobi.

Hon. Speaker, in the statement the Chairperson should inquire into and report on: -

1. Reasons the patient was allegedly turned away by the gangs from the hospital;

- 2. Measures the County Executive and NMS are taking to ensure attainment of a conducive and sustainable working environment for the County health workers that shall guarantee continuity in the provision of quality healthcare; and
- 3. Measures the County Executive and Nairobi Metropolitan Service are taking in particular to enhance the maternal health care services to all County hospitals in Nairobi.

Thank you Mr. Speaker.

**Hon. Speaker**: Chair Health Services, how long do you think you will be able to respond to Doris' statement?

Hon. Moses Ogeto: Hon Speaker she can give us two weeks, on behalf of the Chair, and am a Member of Health Committee

**Hon. Doris Kanario:** Hon. Speaker, this is an urgent matter and it regards a human being and a life. Therefore, Hon. Speaker, two weeks is too much for this matter, thank you.

Hon. Speaker: Can we be able to dispense it soon than two weeks?

**Hon. Moses Ogeto**: Hon. Speaker the Standing Order is very clear for invitation unless otherwise the Speaker make such a ruling. The invitation for those Executive Members to appear before the Committee in the Standing Order is about seven days. Hon. Speaker, I can commit myself before the House that we can do it in nine days, so that the variance of seven days is taken into consideration.

**Hon. Doris Kanario:** Hon. Speaker I still beg to defer because this is an extra ordinary matter, which requires extra ordinary measures. Therefore, I think it calls for some urgency and if the Member does not see any urgency in this, I do not think if he really cares. We are talking about the life of a mother and a newborn who almost lost their life in a County hospital in this City. Thank you.

**Hon. Speaker:** Thank you and I have heard you, but you know what Hon. Ogeto is saying, we are also duty bound by procedures and some time lines. However, the sooner they will be able to dispense with and make sure to get the correct information, thank you.

**Hon. Speaker:** Hon. Member, kindly be guided that this is the procedure under our Standing Orders. So, we have nothing else other than to do what is entitled in that order. But it does not mean that there is anyone who is lesser, it is only that it is the procedure.

**Hon. Doris Kanario:** Thank you again, Hon. Speaker. Mine is just to congratulate the four members. I take this opportunity to congratulate our women leaders, Hon. Emily Oduor and Hon. Immapet Kemunto. Slowly, I can see we are achieving the two third gender rule in this Assembly. I also congratulate Jubilee and NASA parties. Thank you.
