MESSAGES

REFUSAL TO ASSENT THE NAIROBI CITY COUNTY APPROPRIATIONS BILL, 2020 (ASSEMBLY BILL NO. 6 OF 2020)

Hon. Speaker: Hon. Members, I have a message from the Governor. Hon. Members, Standing Order 43(1) relating to the Messages from the Governor provides that "The Speaker shall read to the County Assembly any message from the Governor or the Senator of the County delivered to the Speaker for communication to the County Assembly".

In this regard, Hon. Members, I wish to report that I received a Message on Wednesday 15th October, 2020 from the Governor vide a letter of 15th October, 2020. I wish to inform you that on the 15th October 2020 at the rise of the Assembly I received a message from His Excellency the Governor Mike Mbuvi Sonko by the letter reference NCC/GOV/VOL 1/OCT.20/004 dated the same day.

Hon. Members, the message regards the refusal to assent the Nairobi City County Appropriation Bill Assembly Bill, (Assembly Bill No.6 of 2020). Hon. Members, Standing order 43 (2) further provides, and I quote, "If a message is received from the Governor or the Senator of the County, at a time when the County Assembly is not in session, the Speaker shall forthwith cause the message to be transmitted to every Member and shall report the message to the County Assembly on the day the County Assembly next sits".

In this regard, I wish to confirm that this message was received while the Assembly was not in session having adjourned for the short recess. However, the electronic version of the message was circulated to all Members on Thursday, 29th October, 2020. Accordingly, Hon. Members I now wish to convey the following message.

Refusal to assent the Nairobi City County Appropriations Bill, 2020, (Assembly Bill No. 6 of 2020) pursuant to section 24 (2) (b) of the County Government Act 2012 and Standing Order 145 (2) (b).

Hon. Members, you may recall that on Thursday 8th October, 2020 the County Assembly passed Nairobi City County Appropriations Bill, 2020 (Assembly Bill No. 6 of 2020).

Thereafter, I presented the Bill for assent to His Excellency the Governor on Friday 9th October, 2020. In accordance with the provision of section 24 of the County Government Act 2012 and Standing Order 145. However, on Wednesday 15th October, 2020 His Excellency the Governor, by way of memorandum referred the Bill back to the County Assembly for reconsideration pursuant to provisions of Section 24(2) (b) of the County Government Act, of 2012 and the Standing Order 145 (2) (b).

Hon. Members, pursuant to Standing Order No. 146, the memorandum was committee to the Committee on County Finance, Budget and Appropriation for consideration and reporting. The committee is expected to table its report within 21 days with effect from Thursday 29th October 2020. Thereafter, I will issue directions on how the assembly shall proceed with the business. Thank you.
