# REQUEST FOR A STATEMENT REGARDING THE PAYMENT OF YOUTHS WHO ARE ENGAGED IN CLEAN-UP EXERCISES UNDERTAKEN IN ALL THE 85 WARDS IN THE COUNTY

**Hon. Jeremiah Themendu:** Hon. Speaker, pursuant to Standing Order 45 (2)(c), I wish to request for a statement from the Chairperson of the sectoral committee on Environment and Natural Resources regarding the payment of youths who are engaged in clean-up exercises adding that it is an initiative that was undertaken in all the 85 wards in the County.

Hon. Speaker, in 2018, youths totaling more than 1,000 in number were engaged by the County Government to assist in the cleanup exercise to remove garbage and unblock clogged drainage systems in various parts pf the County. However, the youths involved tin the exercise have never been paid to date.

Hon. Speaker, in the chairperson should inquire into and report on;

- 1. Whether the County Government budgeted for the clean-up exercise?
- 2. Measures the County Executive is taking to urgently pay the youths their arrears for 8 months considering that most of such youths have been hard hit by the Covid-19 pandemic.

3. Reasons the County Executive has not published a fully functioning information desk to handle public grievances in this time?

Hon. Speaker, it is painful that those youths are languishing in poverty yet they did a commendable job to assist to unclog those drainage and help stop floods in the County. Thank you Hon. Speaker

  - iii. 'informal trade' means "unorganized small scale, self-employment creating activities which might involve individuals or unremunerated relatives of the business owner, small

number of hired workers or totally without any hired workers which the street vendors engage in for the purpose of increasing income generation".

I wish to say that it has been a journey assisted by most of the Members in this House to make sure this Bill is done properly.

I would like to say that this Bill covers majorly most of the sections and it talks about the registration of street vendors and pop-up Markets formation and setup. It is something that will benefit this County more to reorganize the street vendors in the streets and the cropping up of the next frontier in traders and businesses, which is the pop-up market industry that happens in many parts of the world.

It is something that I pride myself on by saying that if it happens especially in Nairobi if certain streets can be closed so that the vendors can put their goods, do their sales, and make a few coins. This would allow them to provide for a needy student somewhere or put food on the table if you are a street vendor. Then I think I will be very happy to see that happens. I do not know if am supposed to call a seconder. Okay, thank you very much I move. Thank you.
