RESOLUTION TO NAME OR RENAME A ROAD IN CBD IN HONOUR OF MOHAMED YUSUF HAJI

Hon. Abdi Hassan: Thank you, Mr. Speaker Sir, I beg to give Notice of the following Motion: That aware the recognition of the outstanding citizens who have contributed immensely to this National good is provided for in law, by which the states confer orders decorations and medals. Recognizing that in furtherance of this recognition County Government has equally named roads and other County-owned facilities after heroes and heroines, in recognition of their effort and service to the Nation, which service has contributed to Kenyans prosperity. Observing that the late Hon. Senator Mohammed Yusuf Haji has for fifty-five years served Kenya in various capacities, where he began his public service career as a District Officer in 1960 and rose through the ranks to the position of Provisional Commissioner for several years. Noting that from his public Administration experience, Hon. Haji went on to serve as a Member of Parliament for Ijara Constituency, as an Assistant Minister in the office of the President and later on as Minister of State for Cabinet Affairs in 2002, Minister of state for defense, as an acting Minister for Internal Security and Provincial Affairs. During which he was notable for his efforts to promote peace and stability in Somalia and beyond, amongst other achievements. Grateful that before his demise, the Country had further called upon Hon. Haji exceptional negotiation and strategic mediation skills, by entrusting on him the stewardship of the Building Bridges Initiative, which task he took with earnest zeal and delivered a noteworthy Constitutional Amendment Bill whose processing is currently underway. Annual Budget and Estimates

- "52 A (I) At least three months before the commencement of each financial year, the Board shall cause to be prepared budget estimates of the Fund for that year.
- (2) The Board shall approve the annual estimates at least ninety days before the commencement of the financial year to which they relate and, once approved, the sum provided in the estimates shall be submitted to the County Executive Committee Member for final approval.
- (3) No expenditure shall be incurred for the purposes of the Board except in accordance with the annual estimates approved under subsection
- (4), or in exceptional circumstances, in accordance with an authorization of the Board given with prior written approval of the county executive committee member.

NEW CLAUSE

Books of Accounts

- 52 B (1) The Board shall cause to be kept proper books of accounts and records of the Fund.
- (2) The accounts and financial statements and records of the Board shall be audited and reported upon in accordance with provisions of the Public Audit Act.
