NOTICES OF MOTION

Hon. Millicent Jagero: Thank you Mr. Speaker. I beg to give Notice of the following motion; that, aware that Article 43 (1) of the Constitution provides that every person has the right to the highest attainable standards of health which includes the right to healthcare services including reproductive healthcare; further aware that health services including county health facilities and primary healthcare have being devolved to the County Government pursuant to Paragraph Two of Part Two of the Forth Schedule to the Constitution; disturbed that the attainment of the foregoing objective remains a challenge given the dire shortage of health workers and equipment within the county; further disturbed that while access and use of high quality and comprehensive sexual reproductive health services to prevent or mitigate many of the poor health outcomes experienced among adolescents and youth; noting that a wide range of barriers including social cultural and structural barriers prevent young people from accessing these services; acknowledging that the National Government has developed the national guidelines on provision of adolescents and youth friendly services across the country, this assembly urges the County Executive in conjunction with the Nairobi Metropolitan Services to:

1. Develop the County Adolescents and Youth Reproductive Health Strategy Paper
2. Domesticate the national guidelines for provision of adolescents and youth friendly services with necessary modifications to improve availability, accessibility, acceptability and use of quality sexual and reproductive health services by adolescents and youth seeking services in all the county health facilities within the county.

Hon. Waithera Chege: Thank you Mr. Speaker. I was still going to stand on a Point of Order 45 (2) (c). Mr. Speaker your office must be respected. The last time we had Hon. Majiwa on that chair, he directed that the Chair Environment bring a response within five days after Tuesday on why Nairobi South and Nairobi County as a whole, garbage has not been collected. That has not been honored.

I wish to request from your desk that because the Executive has not been able to help us on this issue, you have powers given by this assembly to help us on this particular issue. If you pass through Nairobi South right now and you know it is the gateway to Mombasa Road, it is in a pathetic state. I really need your intervention and I am sure by using Standing Order No. 1, you can intervene. I therefore request for your intervention.

Hon. Temporary Deputy Speaker: Thank you Hon. Waithera. I also order the same, the secretariat to communicate to the Chair and he should attend the next sitting. What is the Point of Order my brother?

(Point of Order)

Hon. Daniel Muturi: Thank you very much Hon. Speaker. I beg to point out that indeed the Hon. Chair of Environment did say that he would give a response within two weeks. I have got a list of pending statements here some are from 2016.

Hon. Speaker, when I was elected I was told in Kiswahili that, *'miaka tano sio mingi'* Indeed that time has come and I need to complete work for Nairobians in the CBD because nothing has been done. I need guidance from the Chair on how to deal with these issues because we are going on recess soon and when we come back it will be only for a few days and then we hit the campaign trail.

How does the Chair propose that we handle all these pending issues conclusively? I repeat my question Hon. Speaker; how does the Speaker propose that we handle the pending issues conclusively? Thank you very much Hon. Speaker.

Hon. Temporary Deputy Speaker: I order the secretariat to give us the list of unanswered statements so that you can go to the person involved. Thank you.

BILL

THE NAIROBI CITY COUNTY AIR QUALITY BILL 2021, ASSEMBLY BILL NO. 12 OF 2021

Second Reading

Hon. Waithera Chege: Thank you Mr. Speaker. I beg to move that the Nairobi City County Air Quality Bill 2021, Assembly Bill No. 12 of 2021, be read a second time. Mr. Speaker, I do not really want to belabor on this bill because of two things. One, before today, we debated about this bill with my colleagues and number two, the Second Reading is coming on a day when we are still having young children within three estates within Nairobi South Ward admitted in hospital because of air pollution. The reason number three, is on what I have just raised as a point of order.

One of the reasons why we are passing this bill is to make sure that we deal with the challenges of air quality in Nairobi. We do not have to wait for the passing of this bill for some of these things to be implemented. Sometimes I even wonder about some of the work that we have done here since the time we were sworn in, does the Executive really care? We have passed motions and bills here. I have been able to give a proper case study of what has been happening in Nairobi as a result of not considering with dealing with issues of air quality in Nairobi.

Mr. Speaker, allow me to take this assembly back to the year 2019 where National Environment Management Authority (NEMA) was summoned by the Environment Committee, we are now in the year 2022, and NEMA has never agreed to attend to any summons, whether committee's or the Speaker's letters. This really worries me because the Constitution of Kenya 2010 gives NEMA full mandate. When you go to the Fourth Schedule of our Constitution, it goes ahead even to give The County Government the mandate to deal with air pollution.

Mr. Speaker, we are lost for words because last evening but one, I was able to get into one of the WhatsApp pages for Eagle Plains Residents Associations, and half of the families of that estate did not take their children to school that morning because everybody woke up with a dry throat, coughing and itchy eyes, and this thing was not stopping.

Mr. Speaker, in the year 2018 we requested the United Nations Environmental Programme (UNEP) to give us a vehicle that was stationed in a certain location to measure air quality within that location. You will be shocked that up to now those results were not even given to the people who had requested them. I had the chance to interact with those results at the location. You will be shocked by the levels of air pollution along Road C, Mr. Speaker. Road C is along the junction of Likoni Road and Nairobi South.

Mr. Speaker, the reason why I am giving you the data that came from UNEP, is because on several occasions I have tried to request the Executive to deal with this issue without any action. Even as I request my colleagues to pass this law, I am still asking myself if the Executive is committed to implement these laws that we have passed in this House.

Mr. Speaker if you could may be during weekends pass through Kariobangi South, it is an area surrounded by industries, people think that it is mere smoke that they see in the air. But we have done a case study for Mlolongo which is a neighbor to Nairobi County. If you look at the bill that we are proposing today, it addresses the issue of inter-county boundaries. The air pollution at Mlolongo is enough to affect the people in Nairobi County. Two children of a family that came to us from Mlolongo were sick and one child was admitted to hospital with an extra-large head. They testified that from the time that they moved from Mlolongo to a better environment, the child is okay.

Some of these examples shows you that there is a need not only for us to have this law put in place but to have officers working for the government being human enough to understand the challenges that Nairobians are facing, Mr. Speaker. I feel that we need to move with speed because the Kenya Bureau of Statics has been able to show that 18,000 Nairobians suffer from disability as a result of air pollution. If you want to extend to East Africa and Africa at large, globally, the data is three million, and that is not a small number.

Sometimes you cannot be able to see the air pollution. I want to give examples three companies; one called Edible Oils, Powerex and East African Company that are situated near General Motors, the reason why I am mentioning these companies is because NEMA has given a report showing that the three are leading companies in polluting air in Nairobi.

You will be shocked that Edible Oils went ahead to even reopen the company without NEMA giving them a clean bill of record. Edible Oils is a company situated right behind Eagle Plains Estate. When the residents complain, they have a right to complain---

Hon. Temporary Deputy Speaker: Thank you very much, Hon. Waithera. I have heard you clearly. Do you have any additions?

Hon. Waithera Chege: Mr. Speaker, I thought we are on the Second Reading.

Hon. Temporary Deputy Speaker: By the way, you still have time. You have about three minutes to go.

Hon. Waithera Chege: Thank you, Mr. Speaker. I was actually concluding. Thank you for reminding me about time.

Mr. Speaker, my work this afternoon is to urge my colleagues that we are not only bringing this Bill on the floor of the House for the sake of doing it, but we want to save lives that have been shown as a matter of fact from the Kenya Bureau of Statistics on how air pollution affects Nairobi residents.

Therefore, Mr. Speaker, allow me to call Hon. Ngengi to second the Bill, and also we can have some Members debate the Bill. Thank you, Mr. Speaker.

Hon. Temporary Deputy Speaker: Thank you, Hon. Waithera for keeping time. Hon. Ngengi.

Hon. Daniel Muturi: Thank you, Mr. Speaker. I rise to second this Motion. First of all, I would like to appreciate Hon. Waithera Chege for bringing this Motion.

Hon. Speaker, the objective of this Bill is to give effect to Paragraph 3 of Part Two of the Fourth Schedule of the Constitution of Kenya, which deals with formulation of policies and frameworks to control pollution.

Hon. Speaker, the Bill will help to establish control of local emissions, standards, control of activities of vehicles, both private large and small, establish general provision of enforcement of the law and finally establish effective implementation of the national regulations on air pollution.

Hon. Speaker, I share Hon. Waithera Chege's frustrations because I was in this House when she brought this Bill. At that time, NEMA stood accused of impunity because they do not seem to care and they have never sent a representative nor address any of the issues mentioned. Nairobi County is suffering on issues of garbage, which is part of pollution. We have a seconded director from NEMA with the NMS. One has to bring a substantive motion to mention the name. With sheer incompetence, he never picks phone calls and never deals with anything. Where I would be frustrated, I am on a payroll of the Nairobi County. When issues are not addressed, whether the one Hon. Waithera Chege was talking about the garbage in South B or the one in the Nairobi CBD in the markets, which no statement has been responded, it becomes a big issue. To me, it is an oxymoron, I don't understand it. The minute we do not invest in this kind of Bill where the air has to be clean, we are having children and adults suffering from respiratory diseases. This is a cost to the country. This is a cost to the NHIF. It does not make sense at all.

The other day, we passed a Bill on Preventative of Violent Extremism. This is something we should also be having preventative measures. We were always told prevention is better than cure. So, why are we still debating on the same thing since 1963? We are going to almost 60 years as a country but we are still here standing about the same thing.

The CBD right here on Moi Avenue, Tom Mboya Street, Hakati Street in Bus Station and all the alleys, the NMS, which I highly condemn, have established illegal matatu stops in every corner. Those vehicles park there with their engines running all day and there is inspectorate. The law and order do not do anything about it. There have been even deaths in terms of accidents, but we do nothing. We have brought statements here. Hon. Waithera was clear that you may not see the pollution, but those carbon particles lodge on our lungs. When this happens, you will never get them out. We are no longer productive. We are tired all the time. But we are doing nothing about it. I have read articles from some newspapers describing the Governor. We cannot fail Nairobians like this.

Hon. Speaker, combating pollution in all its forms is critical if the sustainable development agenda is to be achieved through this House. Therefore, this Bill seeks to create a system that controls air pollution. Everyone here resides in Nairobi and is affected by this. Your children and grandchildren are affected by this. So, this is not something that is isolated, this is whole of Nairobi. We have had motions brought here by Hon. Kabiro about planting trees, simple things. We have the KFS here and donors who give us trees, but this county seems to be run by what is called *kipindi*, where everyone here is busy running up and down. If we did a small percentage of what we are supposed to do, I would be very happy.

Hon. Speaker, as I had mentioned, we are all affected. As a governor of a county, whether Nairobi or Kilifi, you must have a pet project. You must have something which drives you. Is it environment, health or education? What amazes me is that we don't have any drive.

With those few remarks, I beg to second the Motion, and pray something will happen and some work will be done about this.

Hon. Emmamet Kemunto: Thank you, Mr. Speaker. It has been awhile since I saw you in this Chamber. I appreciate that you are alive and kicking.

I support this Motion. I come from an informal settlement. This issue of garbage not being collected has been a menace. In where I represent legislative wise, we had a whole community demonstrating just to get garbage collected. Some people burn plastics which intoxicate the environment yet we have children. This affects their health. I stand here as a mother. The Executive has really failed us. Even NEMA itself is not working as it should. People cannot be crying day in day out. If we are earning salaries without ensuring the wellbeing of our residents, then there is no business of you coming to the Assembly. All of us are human beings, and you need to do good when you are alive and leave a legacy. Thank you, Mr. Speaker.

Hon. Temporary Deputy Speaker: Thank you. Anybody else? Mover.
