STATEMENT

REQUEST FOR STATEMENT REGARDING THE COLLECTION OF GARBAGE IN NAIROBI COUNTY, ESPECIALLY IN MUTHURWA AND MARIKITI MARKETS

Hon. Speaker: I understand that we have a statement. Hon. Daniel Ngengi!

Hon. Daniel Muturi: Thank you. Hon. Speaker, pursuant to Standing Order No. 45 (2) (c), I wish to request for a statement from the Chairperson of the Sectoral Committee on Environment and Natural Resources regarding the collection of garbage in Nairobi County, especially in Muthurwa and Marikiti Markets.

Hon. Speaker, the two markets are vital as they aid in the supply of substantial amount of food consumed in Nairobi. Notably, the place has been left stinking with food, clogged drainage systems and littered waste depict the unapologetic state of the market, where garbage collection activity is scarce and a clear demonstration of disparity in the work done by the garbage collectors, thereby creating a major conduit for graft.

Hon. Speaker, regrettably, the garbage collectors have since destroyed the only road by the excavators and later big pits that are risky to both the pedestrians, lorries and matatus plying the Central Business District and terminating at Muthurwa stage. A case for instance was witnessed a couple of days ago where near death scenarios were reported in relation to the risky site.

Hon. Speaker, despite numerous complaints since 2019 and several meetings with the Nairobi City County officials in 2018, and now with the Nairobi Metropolitan Services in the last two years whose main objective was to take action and redeem the situation there, it seems that no positive action has been taken by the County. There were attempts by the Nairobi Metropolitan Services to build the material recovery facility which has since been abandoned and left incomplete.

Hon. Speaker, in the statement, the Chairperson should inquire into and report on:

- i. When the NMS will complete the material recovery facility, cover the pits and fix the road in the market and ensure effectiveness when it comes to garbage collection in the said areas; and
- ii. The policy measures that the County has put in place to ensure proper monitoring of the garbage collection in the County in order to enhance efficiency.

Hon. Speaker, with a bit of leeway, you will indulge me on this issue----

Hon. Speaker: Before I indulge you, let me see whether we have the Chair. Is the Chair online? Deputy Majority, you will do an undertaking?

Hon. Peter Wanyoike: Mr. Speaker, let me take the undertaking and report back within two weeks. Hon. Speaker: Hon. Member, do you have further statements as he takes notes on what need to be done to his statement?

Hon. Daniel Muturi: Thank you Hon. Speaker. It is a bit discouraging having been in this House for the last four years and we have done a lot of work for Nairobians, we have done roads, NMTs, clinics among others, yet markets – I speak for Muthurwa and all markets in Nairobi where our food is sourced from – the garbage remains uncollected. It has become a risk place, where not only accidents happen but we can also get diseases because of poor drainages.

Hon. Speaker, two days ago, we almost had a near death experience. Thanks for your indulgence, Hon. Speaker because we have been coming here and making statements. I made few statements some time back about matatus, and a girl got crushed. Till today, no action has been taken. So, when you see me begging for your indulgence, it is because this is an emotional issue. Not only that, it is also life threatening. If indeed within two weeks – because last time I asked questions and was told two weeks by the various committees but I have never gotten a reply, but due to the risk to the risk to our lives, to the pedestrians, and to the Marikiti and Muthurwa markets – kindly let it be within that time. I will be okay with it. Thank you, Hon. Speaker.

Hon. Speaker: Thank you. Also, do a follow up of what the Deputy Majority Leader has said. I believe the report will be ready in two weeks. Can we go to the next Order?
