8. *MOTION – HON. SILVIA MUSEIYA, MCA

Subject: Mechanisms to encourage native languages in ECD Centers

THAT, aware that the Article 14 of the United Nations Declaration on the Rights of Indigenous Peoples provides for the right of indigenous communities to establish and control their educational systems and institutions providing education in their own languages and promoting their culture; FURTHER AWARE that the fourth objective of the 2030 Agenda for Sustainable Development is "to ensure an inclusive and equitable quality education and to promote lifelong learning opportunities for all" which for indigenous communities means ensuring an education that guarantees the learning of their own language and culture; NOTING that the Constitution of Kenya, 2010, similarly provides for the promotion and protection of culture and indigenous languages and knowledge; OBSERVING that language is the main form of interaction with our environment and that words preserve stories, traditions, culture and identity; COGNISANT of the fact that indigenous languages represent the legacy of our forbearers and our obligation is to take care of them because when an indigenous language disappears, the indigenous traditional knowledge (stories, legends, songs, values, myths, prayers) also disappear; APPRECIATING that the treasure of

indigenous languages is a heritage that should not be lost; **DEEPLY CONCERNED** that unfortunately, indigenous cultural identity and languages are threatened by the constant growth and assimilation of globalization within cosmopolitan cities such as Nairobi; this Assembly **urges** the County Executive to explore mechanisms for developing a framework under Section 17 of the Nairobi City County Early Childhood Education Act, 2017 for encouraging learners in ECD Centers to experience their native languages, knowledge and culture to promote all-inclusive early learning in the County.

IT IS NOTIFIED that the Select Committee on Assembly Business, at its last meeting, approved the following *tentative* business to appear in the Order Paper for Thursday, 8th August, 2019: -

A. MOTION - THE LEADER OF MAJORITY PARTY, MCA

Subject: House Allowance for Members of the County Assembly

THAT, aware that devolved Governments are a key component of governance in the Republic of Kenya established under Article 11 of the Constitution 2010; further aware that the office of Member of the County Assembly has been strongly anchored as a fundamental component in the County Administrative System; cognizant of the remunerative needs of each public and State officer to ensure adequate facilitation for successful execution of their duties and mandates; further cognizant of the existence of disparities within the State offices within the Republic on remuneration of the office holders, particularly the payment of house allowances to which the Member of the County Assembly have to their detriment been deprived of; noting that the High Court in the Republic has in Constitutional Petition No. 328 of 2016; Council of Governors versus Salaries and Remuneration Commission pronounced that denying some state officers similar benefits enjoyed by other State officers is discriminatory, unjustifiably selective and contrary to Article 27 of the Constitution, 2010; acquiescing that such conduct is a violation of the fundamental rights of the state officers which such conduct is desirous of denunciation by the Members of the County Assemblies ab initio; whereas the Governing Council of the County assemblies Forum has resolved that the nonpayment of housing allowance for the Members of the County Assembly is a fundamental breach of the rights of the Members; whereas the Governing Council has further resolved and directed that there be effected payment of Housing allowance for Members of the County Assemblies in tandem with the High Court finding; and whereas the resolution of the Governing Council fids precedence and relative applicability from Parliament of Kenya's payment of housing allowance to its Members despite lack of the Salaries and Remuneration Commission directive in affirmative of the same; this assembly resolves to approve and adopt the resolution of the County Assemblies Forum Governing Council that:-

- a) the Salaries and Remuneration Commission (S.R.C) do set housing allowance for Members of the County Assembly in tandem with the ideal and adequate endowment;
- b) the set house allowance be effected and implemented as of the date of issue of the ruling of the High Court in Constitutional Petition No. 328 of 2016 being the 5th day of October, 2018; and
- c) the implementation of the payment of the house allowance to the Members of the County Assembly be commenced with immediate effect upon action by S.R.C.
