THAT, aware that Article 53 of the Constitution of Kenya 2010 stipulates that every child has the right to free and compulsory education; further aware that the function of basic education has been devolved pursuant to paragraph 9 of Part 2 of the Fourth Schedule to the Constitution of Kenya; deeply concerned that many school-going children within the Nairobi City County cannot access early childhood education and others cannot be retained in school due to lack of school fees especially those in informal settlements in the County; noting that basic education is one of the key pillars of a functioning education system; this Assembly urges the County Government to ensure that there is free education in all Public Early Childhood Education Centres in the County.

NOTICE

The Assembly resolved on Thursday, February 19, 2015 as follows:-

- I. THAT, notwithstanding the provisions of Standing Order 94(4), this Assembly orders that, each speech in a debate on Bills sponsored by a Committee, the Leader of the Majority Party or the Leader of the Minority Party be limited as follows:- A maximum of forty five (45) minutes for the Mover, in moving and fifteen minutes (15) in replying, a maximum of thirty (30) minutes for the Chairperson of the relevant Committee (if the Bill is not sponsored by the relevant Committee), and a maximum of ten (10) minutes for any other Member speaking, except the Leader of the Majority Party and the Leader of the Minority Party, who shall be limited to a maximum of fifteen Minutes (15) each (if the Bill is not sponsored by either of them); and that priority in speaking be accorded to the Leader of the Majority Party, the Leader of the Minority Party and the Chairperson of the relevant Sectoral Committee, in that Order.
- II. THAT, notwithstanding the provisions of Standing Order 94(4), this Assembly orders that, each speech in a debate on any Motion, including a Special motion be limited in the following manner:- A maximum of three hours with not more than twenty (20) minutes for the Mover and ten (10) minutes for each other Member speaking, except the Leader of the Majority Party and the Leader of the Minority Party, who shall be limited to a maximum of fifteen (15) minutes each, and that ten (10) minutes before the expiry of the time, the Mover shall be called upon to reply; and that priority in speaking be accorded to the Leader of the Majority Party, the Leader of the Minority Party and the Chairperson of the relevant Sectoral Committee, in that Order.
