NOTICES

I. THE NAIROBI CITY COUNTY CULTURAL HERITAGE BILL, 2017
(ASSEMBLY BILL NO.1 OF 2017.

NOTICE is given that the chairperson of the Committee on Culture and Social Services intends to move the following amendments to the Nairobi City County Cultural Heritage Bill, 2017 at the Committee Stage—

CLAUSE 2

THAT, clause 2 be amended in the definition of the word **“cultural heritage”** by inserting the words **“of County importance”** immediately after the word **“sites”**.

PART I

THAT part I be amended-

- (i) by inserting a new part immediately after PART I as follows:-

“PART I (A)-FINANCIAL PROVISIONS”

NEW CLAUSE

- (ii) by inserting a new Clauses under PART I(A) as follows:-

“4A. There is established the County Culture Fund, which shall be administered by the Department.”

“4B. The fund shall be financed from-

- (a) such monies appropriated from the County Revenue;**
- (b) such monies or assets as may accrue to the Department in the course of the exercise of its powers or the performance of its functions under this Act;**
- (c) grants from the national and other county governments;**
- (d) aid or donation from national and international agencies; and**
- (e) any monies from any other source provided or donated to the directorate.”**

“4C. The fund shall be used towards meeting the expenses of implementation of this Act”

CLAUSE 4

THAT, clause 4 be amended-

- (i) in paragraph (a) by deleting the word **“Part”** appearing immediately after the word **“this”** and substituting therefor the word **“Act”**.
- (ii) in paragraph (b) by inserting the words **“or its successor”** immediately after the word **“Kenya”**;

CLAUSE 9

THAT, clause 9 be amended-

NEW PARAGRAPH

- (i) in sub clause (2) by inserting a new paragraph immediately after paragraph (a) as follows:-
“(aa) the Chief Officer in charge of the Department;”

NEW SUBPARAGRAPH

- (ii) in sub clause (2) by inserting a new subparagraph immediately after sub paragraph (iii) as follows:-
“(iii) (a) a representative of the youth involved in the arts;”

CLAUSE 11

THAT, clause 11 be amended in paragraph (a) by deleting the word **“patenting”** appearing immediately before the word **“purchasing”**.

CLAUSE 13

THAT, clause 13 be amended in sub clause (2) by deleting the words **“and where possible, provide financial support to ensure the establishment of the industry”** appearing immediately after the word **“community”**.

CLAUSE 14

THAT, clause 14 be amended in sub clause (1) by inserting the word **“county”** immediately after the words **“declare any site to be a”**

II. Assembly resolved on Wednesday, February 15, 2017 as follows:-

THAT, notwithstanding the provisions of Standing Order 94(4), this Assembly orders that, each speech in a debate on **Bills NOT sponsored by a Committee**, the Leader of the Majority Party or the Leader of the Minority Party be limited as follows:- A maximum of three hours and thirty minutes, with not more than thirty (30) minutes for the Mover, in moving and ten (10) minutes in replying, a maximum of thirty (30) minutes for the Chairperson of the relevant Committee and a maximum of ten (10) minutes for any other Member speaking, except the Leader of the Majority Party and the Leader of the Minority Party, who shall be limited to a maximum of fifteen Minutes (15) each; and that priority in speaking be accorded to the Leader of the Majority Party, the Leader of the Minority Party and the Chairperson of the relevant Sectoral Committee, in that Order.
