### MOTION- APPOINTMENT OF A NAIROBI CITY MANAGEMENT BOARD.

(Hon. Peter Imwatok, Mca)

**THAT**, aware that the Urban Areas and Cities Act, 2011 ("the Act") broadly provides for the classification, governance and management of urban areas and cities; NOTING that Section 12 of the Act vests all powers to the County Government in the management of a City but the City shall be administered on behalf the County Government by a board constituted in accordance with Section 13 of the Act and a manager appointed pursuant to Section 28 of the Act; DEEPLY CONCERNED that roughly six years since the establishment of the County Government the implementation of the Act remains a mirage, despite the glaring need for the framework provided by the Act in restoring and regenerating the City and its environs; RECOGNIZING that in cities such as Kisumu the public has petitioned the High Court to compel the County Government of Kisumu to constitute the City Management Board, signifying the critical role this Board can play in the success of any City as enshrined in the enabling law; this Assembly RESOLVES that the County Executive Committee

urgently take the necessary measures pursuant to Section 13 of the Urban Areas and Cities Act, 2011, and appoint a Nairobi City Management Board.
