6. <u>NOTICE OF MOTION</u> – HON. PIUS M. MBONO, MCA

Madam Speaker, I beg to give Notice of the following Motion -

THAT AWARE, that Article 175(b) of the Constitution on the principles of devolved government provides that *county governments shall have reliable sources of revenue to enable them govern and deliver services effectively;***NOTING** that street vendors or business people commonly referred to as hawkers have the potential to contribute immensely to the City's revenue streams and create job opportunities if the sector is well managed; **DEEPLY CONCERNED** that frequent violent confrontations between City askaris and hawkers has not solved the challenges associated with the sector and only worsened the situation; **FURTHER NOTING** that various back streets and avenues remain underutilized in terms of the potential for street vending e.g.

Aru Lane, Gaberone, Taveta and lanes joining Kirinyaga and Lower Kirinyaga roads; this Assembly urges the County Executive to rehabilitate these streets and lanes and utilize them to provide space for street vendors within certain strict parameters per planning requirements and operating timelines for instance from 5.30pm to 5.30am at least two days a week etc.

7) NOTICE OF MOTION - HON. PIUS M. MBONO, MCA

THAT AWARE, that part of the Nairobi City County Governor's seven (7) point Agenda is the improvement of traffic management within the CBD, promotion of an enabling environment for job creation, business growth and wealth creation; **OBSERVING** that the attainment of the foregoing might prove difficult given the limited parking space in the City centre, a major contributor to traffic snarl ups and gridlock; **NOTING** that the County has several vacant lots, for instance the parking adjacent to the Supreme Court and many others, which remain underutilized; **APPRECIATING** that some of the plots are utilized as temporary markets over the weekend such as Maasai Market; **FURTHER NOTING** that the plots have the potential to greatly help the City ease congestion by creating additional parking and thus new revenue streams; this Assembly urges the County Executive to consider developing multi-storey parking lots through public private partnerships in all available County plots within the greater CBD to create additional parking space and generate additional crucial revenues as well as create job opportunities.

8) <u>MOTION</u> – HEALTH WORKERS - (Hon. Pius Mbono, MCA)

THAT, aware that Article 43 (1) (a) of the Constitution of Kenya, 2010 provides that every person has the right to the highest attainable standards of health, which includes the right to health care services, including reproductive health care; **APPRECIATING** that Health Services including but not limited to; County health facilities and pharmacies, ambulance services and promotion of primary healthcare were devolved to the County Governments; **FURTHER APPRECIATING** that in provision of

Health Services, Counties deploy the Community Health Workers (CHWS) who voluntarily interlinks the Communities and Health Service providers in providing preventive, promotional and rehabilitation healthcare to communities; **CONCERNED** that the Community Health Workers in the County lacks basic protective gears and tools to enable them effectively provide their voluntary health service to the Communities; **FURTHER CONCERNED** that the Community Health Workers in the County are technically incapacitated due to lack of trainings, seminars and other forms of exposures facilitated by the County Government;
