## 3. STATEMENTS PURSUANT TO STANDING ORDER 45 (2)(c):-

Pursuant to Standing Order 45 (2)(c) the following Members requested for Statements:-

- a) Hon. Abraham Njihia requested for a statement from the Chairperson of the Sectoral Committee on Planning and Housing regarding a plot No. LR 209/11927/3 along Ngong Road which has been encroached by mechanics;
- b) Hon. Jayendra Malde requested for a statement from the Chairperson of the Sectoral Committee on Transport and Public Works regarding street lighting in Parklands/Highridge Ward;
- c) Hon. Jayendra Malde requested for a statement from the Chairperson of the Sectoral Committee on Transport and Public Works regarding dilapidated states of roads in Parklands/Highridge Ward;
- d) Hon. Jayendra Malde requested for a statement from the Chairperson of the Sectoral Committee on Environmentand Natural Resources regarding status of garbage waste collection within Parklands/Highridge Ward;

e) Hon. Chege Waithera requested for a statement from the Chairperson of the Sectoral Committee on Environment and Natural Resources regarding drainage and sewerage infrastructure in Upper Hill area;

# 4. <u>PROCEDURAL MOTION</u> – LIMITATION OF DEBATE ON BILLS SPONSORED BY PARTIES OR COMMITTEES

Motion made and Question proposed

THAT, notwithstanding the provisions of Standing Order 103(4), this Assembly orders that, each speech in a debate on Bills sponsored by a Committee, the Leader of the Majority Party or the Leader of the Minority Party be limited as follows:- A maximum of forty five (45) minutes for the Mover, in moving and fifteen minutes (15) in replying, a maximum of thirty (30) minutes for the Chairperson of the relevant Committee (if the Bill is not sponsored by the relevant Committee), and a maximum of ten (10) minutes for any other Member speaking, except the Leader of the Majority Party and the Leader of the Minority Party, who shall be limited to a maximum of fifteen Minutes (15) each (if the Bill is not sponsored by either of them); and that priorityin speaking be accorded to the Leader of the Majority Party, the Leader of theMinority Party and the Chairperson of the relevant Sectoral Committee, in that Order.

# 5. <u>PROCEDURAL MOTION</u> - LIMITATION OF DEBATE ON BILLS INDIVIDUAL MEMBERS' BILLS

#### Motion made and Question proposed

**THAT**, notwithstanding the provisions of Standing Order 103(4), this Assembly orders that, each speech in a debate on **Bills NOT sponsored by a Committee, the Leader of the Majority Party or the Leader of the Minority Party**be limited as follows: - A maximum of three hours and thirty minutes, with

not more than thirty (30) minutes for the Mover, in moving and ten (10) minutesin replying, a maximum of thirty (30) minutes for the Chairperson of the relevantCommittee and a maximum of ten (10) minutes for any other Member speaking, except the Leader of the Majority Party and the Leader of the Minority Party, who shall be limited to a maximum of fifteen Minutes (15) each; and that priorityin speaking be accorded to the Leader of the Majority Party, the Leader of the Minority Party and the Chairperson of the relevant Sectoral Committee, in thatOrder.

Question put and **Agreed to**.

### 6. PROCEDURAL MOTION - LIMITATION OF DEBATE ON A MOTION

#### Motion made and Question proposed

**THAT**, notwithstanding the provisions of Standing Order 103(4), this Assembly orders that, each speech in a debate on any **Motion**, including a Special motion be limited in the following manner:- A maximum of three hours with not more than twenty (20) minutes for the Mover and ten (10) minutes for each other Member speaking, except the Leader of the Majority Party and the Leader of the Minority Party, who shall be limited to a maximum of fifteen (15) minutes each, and that ten (10) minutes before the expiry of the time, the Mover shall be called upon to reply; and that priority in speaking be accorded to the Leader of the Majority Party, the Leader of the Minority Party and the Chairperson of the relevant Sectoral Committee, in that Order.
