The Speaker conveyed the following Communication;

**DIRECTION ON THE CONSIDERATION OF THE COUNTY FISCAL STRATEGY PAPER – CFSP**

“Honorable Members, as you may be aware, Submission of the County Fiscal Strategy Paper – CFSP is in line with the provisions of Standing Order 221 (1), which requires the County Treasury to submit the County Fiscal Strategy Paper approved by the County Executive Committee in accordance with section 117 of the Public Finance Management Act, 2012, to the County Assembly, by the 28th February of each year.

Honorable Members, the County Fiscal Strategy Paper is the County’s strategy document for Budget preparation that provides the link between the overall policies as identified in the County Integrated Development Plan – CIDP and which includes the Financial Outlook with respect to County Government revenues, expenditure and borrowing for the coming financial year, and for the medium term as indicated in Section 117 (4) of the Public Finance Management Act, 2012.

Accordingly Honorable Members, Standing Order no. 221(3) provides that, and I quote; “Upon being laid before the County Assembly, the County Fiscal Strategy Paper shall be deemed to have been committed to each Sectoral Committee without question put, for each such committee to deliberate upon according to their respective mandates and make recommendations to the Finance, Budget and Appropriations Committee.”

Also, Hon. Members, it is also worth reminding you on the provisions of Standing Order no. 221(7) which provides that The County Assembly shall consider and may adopt the County Fiscal Strategy Paper with or without amendments not later than fourteen days after its submission.

It is so directed.”

Provided that, when the period of Recess proposed by any such motion does not exceed ten (10) days, the debate shall be limited to a maximum of thirty minutes (30), and shall be strictly confined to the question of the adjournment.
