#### 3. COMMUNICATION FROM THE CHAIR

#### - PROVISION OF TEA FOR COMMITTEES

#### Hon. Members,

The Chair is alive to concerns from the Membership regarding the lack of operations at the Assembly cafeteria and the subsequent absence of tea for Committee Meetings, the same having been abruptly stopped in the recent past without much explanation.

**Hon. Members**, the Chair had committed to communicate on this matter soonest possible. I now wish to report that the office of the Speaker has taken up the matter and is working round the clock to ensure operations resume at the Cafeteria. The Welfare of members is the utmost duty of the Chair, and to that the extent the Assembly Service Board has put in place mechanisms for resumption of the provision of tea to Committee meetings and for the membership. The chair will keep the House apprised on this matter regularly until such time as operations fully resume at the Cafeteria.

It is my hope that this rationalization truly aligns the membership of assembly committees with the face of the Assembly as represented by the various Parties.
