- **1.** The Assembly assembled at Thirty Minutes past Two O'clock.
- **2.** The Proceedings were opened with Prayer.

QUORUM OF THE ASSEMBLY

There being no quorum at the commencement of the sitting Hon. Speaker ordered the bell be rung for ten minutes.

There being no quorum at the expiry of the ten minutes, the bell was rung for further five minutes.

There being a quorum at the expiry of the five minutes, the Chair called the Assembly to order.

3. COMMUNICATION FROM THE CHAIR

Honorable Members, I have the following Communication to convey -

Honorable Members, as you all may recall, on Thursday, 14th June 2018, the Hon. Maurice Gari, Member for Nairobi West Ward rose on a point of order pursuant to provision of Standing Order no. 187, seeking direction from the Chair on Public's access to Meetings of the Select Committee and by extension, non-Committee Members.

Honorable Members, the right Hon. Member in his submission registered his dismay for being denied the privilege to attend the proceedings of the Public Accounts Committee on Wednesday, 13th June 2018 as an *amicus curiae* and pursuant to the Assembly Standing Orders. Accordingly **Hon. Members**, you will also recall that the Chair undertook to give direction on the matter before the House.

Hon. Member, Article 196 of the Constitution of Kenya, 2010 compels the County Assembly to; (1) *"conduct its business in an open manner, and hold its sittings and those of its committees, in public."* Further to that; 196(2) provides that; *"A county assembly may not exclude the public, or any*

media, from any sitting unless in exceptional circumstances the speaker has determined that there are justifiable reasons for doing so".

Similarly **Hon. Members**, the same is reiterated by Standing Order no. 190 (1) which provides that; "All committee proceedings shall be open to the public unless in exceptional circumstances the Speaker has determined that there are justifiable reasons for the exclusion of the public."

Honorable Members, Committees are extension of the House and while conducting its Oversight, Legislation and Representation role, is highly advised to abide with the aforementioned provisions. That notwithstanding **Hon. Members**, there are exceptional circumstances where Select Committee meetings may be conducted in closed door.

Honorable Members, accordingly, I direct as follows; that pursuant to provisions of Standing no. 190 (1), all the Committee Chairperson be seeking the Speaker's authority on the Committee's intention to conduct closed doors meetings forthwith with justifications therein for the same at least a day before the sitting of such meeting. It is so directed.

7. MOTION – HON. PETER IMWATOK-MINORITY CHIEF WHIP

Motion made and Question proposed;

THAT, aware that Nairobi City County as the seat of the Country has been on a steady decline over the last two decades, as evidenced by failing

infrastructure and crucial public amenities; **DEEPLY CONCERNED** that most of the development that has taken place in Nairobi over the last two decades has been unplanned and some developers, both residential and business, have failed to take cognizance of laid out City plans by subsequent city administrations, including the newly established County Governments; **REGRETTING** that the result of the foregoing is the evolving chaos that now characterizes life in the City; **REALIZING** that if nothing is done this steady decline spells doom for the Country as a whole, given that Nairobi County contributes roughly 60% of the Republic's GDP; APPRECIATING that the County Government of Nairobi in conjunction with the National Government has embarked on an ambitious program for the rebuilding or the City known as the Nairobi Regeneration Program; NOTING that the program kicked off with the creation of a multiagency taskforce, co-chaired by Governor Mike Sonko and Tourism Cabinet Secretary Najib Balala, and comprising of officers from both levels of government as well as stakeholders who made a restore Nairobi its former commitment to to glory; FURTHER **APPRECIATING** that this program carries great potential for the restoration of the City to global standards; this Assembly **RESOLVES** to fully support the efforts of the National Government to rejuvenate Nairobi City and will take any legislative or policy measures to make that possible when called upon
