- vi. In Vote R5327 under the Programme on Liquor Licensing and Regulation by deleting the supply of 204,836,000
- vii. In Vote R 5327 by inserting the Appropriation in Aid of 204,836,000
- viii. By deleting the total Recurrent Supply of 21,473,786,815 and replacing thereof with total Recurrent supply of 21,268,950,815
- ix. By inserting the total Recurrent Appropriation in Aid of 204,836,000
- x. In Vote D5327 under the Programme on Liquor Licensing and Regulation by deleting the supply of 83,000,000
- xi. In Vote D 5327 by inserting the Appropriation in Aid of 83,000,000
- xii. By deleting the total Development Supply of 10,836,454,000 and replacing thereof with total Recurrent supply of 10,753,454,000
- xiii. By inserting the total Development Appropriation in Aid of 83,000,000
- xiv. By deleting the Grand Total Supply of 32,310,240,815 and replacing thereof with the Grand total Supply of 32,022,404,815
- xv. By inserting the Grand total Appropriation in Aid of 287,836,000
