

# COUNTY GOVERNMENT OF NAIROBI CITY SECOND ASSEMBLY - (THIRD SESSION) NAIROBI CITY COUNTY ASSEMBLY VOTES AND PROCEEDINGS TUESDAY, APRIL 9, 2019 AT 2.30 P.M.

- 1. The Assembly assembled at thirty minutes past Two O'clock.
- 2. The Proceedings were opened with Prayer

## **QUORUM OF THE ASSEMBLY**

The Deputy Speaker having confirmed that there was no Quorum caused the Bell to be rung for Ten minutes.

And there being a Quorum at the expiry of the ten minutes, the Deputy Speaker called the Assembly to order.

### 3. PETITION

Pursuant to Standing Order 208 (1) b, The Member for Utawala (Hon. Patrcik Karani, MCA) presented a Petition on behalf of the Residents of Utawala Ward regarding the Repossession of Public Land LR:No 1645/16/19,1645/16/20,1645/16/21 And 1645/16/22 within Nairobi City County.

# 4. STATEMENTS PURSUANT TO STANDING ORDER 45 (2) (C):-

Pursuant to Standing Order 45 (2) (c) the following Member requested for Statement: -

a. Hon. Patrick Karani, MCA requested for a Statement from the Chairperson of the Sectoral Committee on Labour and Social Welfare regarding the medical scheme for the staff of the Nairobi City County; - response due in two weeks after recess.

Pursuant to Standing Order 45 (2) (c) the following responses to Statements were given: -

- a) The Chairperson of the Sectoral Committee on Justice and Legal Affairs gave response to Statement requested by Hon. Osman Adow, MCA regarding corruption and impropriety by officers of the County Inspectorate Department Response was satisfactorily.
- b) The Chairperson of the Sectoral Committee on Health Services gave a response to Statement requested by Hon. Samora Mwaura, MCA regarding the stalled construction of public health facilities in the Nairobi County for instance, Maji Mazuri Health Centre;
- c) The Chairperson of the Sectoral Committee on Health Services gave aa response to Statement requested by Hon. Francis Ngesa, MCA regarding the alleged operation of illegal clinics in the County specifically the recent case of the late human rights activist Caroline Mwatha who allegedly passed on due to botched abortion in a reportedly unregistered clinic in Dandora i.e New Njiru Clinic in Dandora Ward *Member was not satisfied*.

# 5. MOTION - ESTABLISHMENT OF NEW CAR PARKS AND REHABILITATION OF THE EXISTING ONES

## Motion Made and Question Proposed;

**THAT,** aware that Article 186 (1) of the Constitution of Kenya 2010, and paragraph 5 of the Fourth Schedule to the Constitution provide for the functions and powers of County Government on County transport including county roads, street lighting, public road transport traffic and parking; further aware that the City has designated preferential parking zones and bus termini throughout the City with parking restrictions for each zone; noting that recent years have witnessed a marked increase in the number of vehicles in the County; **concerned** that there are limited number of parking slots across the County making it difficult for motorists to get a slot especially during working hours; further concerned that some of the available parking slots are in a dilapidated state giving motorists option of using private parking services thus denying the County revenue; acknowledging that a good percentage of County revenue is from parking services, this Assembly urges the County Executive to establish more car parks in off-street parking areas outside the Central Business District, build multi-storey car parks in available County land and upgrade the existing ones to ease the pressure on the available spaces, provide efficient parking services to motorists and boost revenue collection for the County.

# 6. MOTION - FORMULATION OF A POLICY FOR INSTALLATION OF SECURITY LIGHTS IN THE COUNTY

# Motion Made and Question Proposed;

**THAT,** aware that Article 29 of the Constitution of Kenya, 2010 grants every citizen a right to freedom and security; further aware that paragraph 5 of Part Two of the Fourth Schedule to the Constitution provides for street lighting as a function of the County Government; noting that recent months have witnessed a marked increase in the number of insecurity incidences across the Country and more so in Nairobi City County; concerned that most of the streets in the County are in darkness due to lack of lighting, which has contributed to an increase in crime within the County as evidenced by muggings and other violent crimes; further concerned that some buildings have no adequate lightning as per the standard practice worldwide; noting that for the County to realize a 24 hour economy, security for business people and residents is indispensable; this Assembly urges the County Executive to formulate a policy to provide for installation of outdoor security lighting in all buildings, gates and streets in the County to be turned on by 7.00 pm to 6.00 am daily.
