- **1.** The Assembly assembled at thirty minutes past Two O'clock.
- **2.** The Proceedings were opened with Prayer.

The Deputy Speaker having confirmed that there was no Quorum at the commencement of the sitting caused the Bell to be rung for Ten minutes.

- a) Hon. Jeremiah Themendu, MCA on behalf of the Chairperson of the Sectoral Committee on Environment and Natural Resources gave a Response to Statement requested by Hon. Waithera Chege, MCA regarding the discharge of industrial effluent gas in the County; and
- b) The Chairperson of the Sectoral Committee on Health Services gave a Response to Statement requested by Hon. Kabiro Mbugua, MCA regarding the alleged use of chemicals for preservation of meat in supermarkets in the County; and

# 4. <u>MOTION – MECHANISMS FOR CARING OF CHILDREN WITH AUTISM IN</u> <u>THE COUNTY</u>

Motion Made and Question Proposed: -

**THAT**, aware that Article 26 of the Constitution of Kenya (2010) gives the citizen of this Country and residents of Nairobi City County a right to life; further aware that Health Services including County Health facilities and primary health care have been devolved to the County Governments pursuant to paragraph 2 of Part Two of the Fourth Schedule to the Constitution; **acknowledging** that autism is development disorder of neurobiological origin that can have a lifelong effect on social

interaction, ability to communicate ideas and feelings, imagination and establishment of relationships; **recognizing** that autism is one of the categories of special education and is a serious, lifelong and disabling condition and without the right support it can have a profound effect to individuals and families; **concerned** that many children with special needs such as those with autism in the County Early Childhood Education Centres drop out school due to unconducive environment occasioned by lack of equipment and facilities; **observing** that one of the functions of the County Persons with disabilities Board is to provide to the maximum extent possible assistive devices, appliances and other equipment to persons with disabilities; and access to available information and technical assistance to all institutions and organizations concerned with the welfare and rehabilitation of persons with disabilities; this Assembly urges the County Executive to:-

- i. Establish, construct, and equip specific classrooms for children with special needs in order to accommodate autistic learners;
- *ii.* Provide early and accurate diagnosis of autism; and
- *iii.* Establish a Committee to address non-compliance and violation with the primary objective being of mastering academic goals to ensure that interventions are accessible and effective so to guarantee the success of include education for learners diagnosed with autism.
