1. The Assembly assembled at Ten O'clock.
2. The Proceedings were opened with Prayer.

QUORUM OF THE ASSEMBLY

The Speaker having confirmed that there was quorum at the commencement of the Assembly called the Assembly to order.

3. MESSAGES

The Speaker conveyed the following Message from the Governor: -

NOMINEE FOR THE POSITION OF THE MEMBER OF THE NAIROBI CITY COUNTY PUBLIC SERVICE BOARD AND SECRETARY TO THE COUNTY PUBLIC SERVICE BOARD

“Hon. Members, Standing Order 43 (1) relating to Messages from the Governor provides that “the Speaker shall read to the County Assembly any message from the Governor or the Senator of the County delivered to the Speaker for Communication to the County Assembly.” In this regard, Hon. Members I wish to report that the Office of the Speaker is in receipt of a Message from H.E the Governor of Nairobi City County on the following:

1. Nomination for the position of the Board Secretary to the Nairobi Public Service Board; and
2. Nomination for the position of Member of the Nairobi Public Service Board.

I now wish to convey the following Message –

A) NOMINEE FOR THE POSITION OF MEMBER TO THE NAIROBI CITY COUNTY PUBLIC SERVICE BOARD AND SECRETARY TO THE COUNTY PUBLIC SERVICE BOARD

Hon. Members as you are aware, Section 58 (1) (b) and Section 58 (1) (c) of the County Governments Act, 2012 provides for the nomination and appointment of a Member and the Secretary to the County Public Service Board respectively, with the approval of the County Assembly, from among persons who are not Members of the Assembly through a competitive process.

Hon. Members, pursuant to the provisions of Section 58 (1) (b) and Section 58 (1)(c) of the County Governments Act, 2012, H.E the Governor hereby nominates **JACK BABJI OWINO** to the position of Member of County Public Service Board; and **PHILIP POLLAND GEORGE KAINGU** to the position of the Secretary to the County Public Service Board.

Hon. Members, I now direct that the Sectoral Committee on Labor and Social Welfare proceed with the vetting of the said nominees.”

4. NOTICE OF MOTION - HON MOSES OGETO, MCA

Subject: Enforcement of notices for repainting of buildings in the County.

THAT, aware that Part Two of the Fourth Schedule to the Constitution of Kenya 2010, the functions and powers of the County Governments, among others, covers public health; further aware that Section 118(b) of the Public Health Act, Cap 242 identifies as nuisance, any dwelling or premises or part of a construction in such a state as dirty to be dangerous to health; **NOTING THAT** that Nairobi County is the entry point into the country by international guests; **FURTHER NOTING THAT** the aesthetic characteristics of the city gives the first impression about its general organization and national character; **COGNIZANT THAT** the County Government and the Nairobi Metropolitan Services (NMS) have separately issued public notices to owners of buildings to repaint in line with their Nairobi City beautification initiative; **CONCERNED THAT** to a large extent, property owners have ignored to comply with the said notices; **REALIZING THAT** the County has the responsibility to make laws and policies in peoples’ interest which they hold in trust; this Assembly resolves the County Executive and the Nairobi Metropolitan Services(NMS) moves with speed to enforce the aforementioned notices on repainting of building’s in the City County.
