QUORUM OF THE ASSEMBLY

The Speaker having confirmed that there was quorum at the commencement of the Assembly called the Assembly to order.

3. COMMUNICATION FORM THE CHAIR

The Speaker conveyed the following communication: -

GUIDANCE ON CONSIDERATION OF THE GOVERNOR'S MEMORANDUM ON THE NAIROBI CITY COUNTY APPROPRIATIONS BILL, 2020

"Honourable Members, I have the following communication to make.

Hon. Members, as you may recall, during the morning sitting I conveyed to the House the Message on the memorandum of H.E the Governor on the Nairobi City County Appropriations Bill, 2020. This was further to the circulation of the electronic version of the same to all Members of the Assembly having been on Short Recess.

Hon. Members, while I recognize the import of the Bill to the life of this County, and more specifically to the service delivery to the citizens, this House is bound and guided by the provisions of the relevant statutes and Standing Orders in processing of specific business that comes before this House.

Hon. Members, our own case is the Nairobi City County Appropriations Bill, 2020 upon which the Assembly Select Committee on County Finance, Budget and Appropriations has deliberated, compiled and Tabled a report. This is in anticipation for the Committee of the Whole Assembly for consideration of the same pursuant to Standing Order this afternoon.

Hon. Members, it is therefore my responsibility to remind and guide the House on the provisions of the relevant statutes and Standing Orders to enable Members make decisions from a more informed position, especially on such a matter that relates to numerical thresholds with relevant consequential provision. Particularly, Standing Order 145 that relates to Assenting to Bills provides as the follows and I quote:

- "(1) The Speaker shall, within fourteen days, forward a Bill passed by the County Assembly to the Governor.
- (2) The Governor shall within fourteen days after receipt of a Bill (a) assent to the Bill; or
 - (b) refer the bill back to the County Assembly with a memorandum outlining reasons for the referral.
- (3) If the Governor refers a Bill back to the County Assembly, the County Assembly may, following the appropriate procedures under this section
 - (a) amend the Bill taking into account the issues raised by the governor; or
 - (b) pass the Bill without amendment."

Additionally, Hon. Members, the Assembly Standing Orders provides for the following actions to be taken whenever either of the situations in Standing Order 145(3) above are presented to the Assembly:

- Standing Order 145(4) provides that "If the County Assembly amends the Bill taking into consideration the issues raised by the Governor, the Speaker shall within fourteen days submit the Bill to the Governor for assent"
- Standing Order 145 (5) provides that "If the County Assembly passes the Bill a second time, without amendment, or with amendments which do not accommodate the Governor's concerns by a vote supported by two-thirds of members of the County Assembly, the Speaker shall within seven days re-submit the Bill to the Governor and the Governor shall within seven days assent to the Bill"

Therefore, Hon. Members, I urge you put the foregoing into consideration as the House proceeds with the consideration of the H.E the Governor's Memorandum on the Nairobi City County Appropriations Bill, 2020.

It is so guided and I thank you Hon. Members".
