Hon. Members, the provisions of section 135 of the Public Finance Management (PFM) Act 2012, and Standing Order 215 (1)

That the County Government Supplementary Budget Estimates and the County Assembly Supplementary Estimates be committee to each sectotal Committee and that these Committees should submit their recommendations to the budget and Appropriations Committee in one weeks' time.

#### **6. MOTION – POOR LOCATION OF FOOD COURTS AND EATING HUBS**

Motion moved and question proposed –

**THAT**, aware that Nairobi City is the hub of East and Central Africa with vast potential and resources for wooing foreign investors especially in the Hospitality industry; concerned that there is poor location of food courts and eating hubs with most of the eating places being housed within or adjacent to major petrol stations within or along major highways thereby exposing consumers to pollution more so to the risk of exposure to the hazardous Benzene Toloen Ethylbenzen and Xylene (BTEX) commonly found in petroleum fumes; this Assembly urges the County Government to take necessary measures to re-locate food courts situated within or adjacent to petrol stations to safer havens.
