1. The House assembled at thirty minutes past Two O'clock.
2. The Proceedings were opened with Prayer.

3. COMMUNICATION FROM THE CHAIR - PENDING STATEMENTS

The Chair conveyed the following communication from the Chair-

“Honorable Members,

“You will recall that on Tuesday, 18th February, 2014, the Chair issued a Communication regarding pending Statements not concluded during the first session of this August Assembly.

The Chair proceeded to give Chairpersons of Sectoral Committees fourteen (14) days within which they were to table those pending responses to Statements requested on the floor of the Assembly.

Hon. Members, the Chair had then noted the reason for that direction as being a practice in commonwealth legislatures that Statements not concluded during a Session automatically lapse at the end of that session.

Indeed most Chairpersons took the direction in their stride and tabled their responses as had been directed.

However, honorable Members, there are Chairpersons of Committees that have yet to respond to pending Statements from the First Session of the Assembly.

The Chair therefore wishes to direct that all pending Statements from the First Session be tabled on Tuesday, 22nd April, 2014. Chairpersons who fail to observe this direction must report to the Speaker reasons for such failure before Tuesday, 22nd April, 2014.
