THAT, aware that the National government disburses a substantial amount of development kitty to the Counties; further aware that the use of such monies for investment is key to the development of the City and the prosperity of its residents; deeply concerned that there has been no substantial investment in development oriented initiatives Nairobi County Government, as evidenced by worsening potholes in the County roads, uncontrolled sewage spills, lack of proper sanitation, disrepair of crucial County public infrastructure across the City; noting that whereas there have been efforts to address the challenges bedeviling the City's development, not much has come from these efforts;

this Assembly adjourns pursuant to Standing Orders number 30 to discuss the challenges bedeviling development investments in the County as a matter of definite and urgent County importance.

THAT, aware that an effective transport system has a significant contribution to the economy of a country; further aware that increased public service vehicle transport has expedited the efficiency of transportation in Kenya and more so in Nairobi City County; deeply concerned that some bus stages are located at road intersections and roundabouts in various County roads, which has contributed to difficulty in accessing acceleration and deceleration lanes resulting in traffic snarl-ups that translate to lost man-hours by motorists, especially during rush hour; this Assembly urges the County Government in conjunction with the National Government to relocate all bus stages away from road junctions and roundabouts to ease traffic within the County.
