4. STATEMENTS PURSUANT TO STANDING ORDER 41(2)(c)

Pursuant to the provisions of Standing Order 41(2) (c), the following Members sought statements –

- i) Hon. Alexander Mulatya requested for a statement from the Chairperson of the Select Committee on Ward Development Fund regarding inflicts of road construction in Embakasi Ward.
- ii) Hon. Kenneth Thugi Muroki requested for a statement from the Chairperson of the Sectoral Committee on Labour and Social Services

The following responses to statements were given:-

a) The Chairperson of the Sectoral Committee on Planning and Housing gave a response to statement requested by Hon. Jaffer Kassam regarding the grabbed piece of land LR number 1870/111/462 belonging to Bohra Primary School Highridge, Parklands Ward by a private developer.

- b) The Chairperson of the Sectoral Committee on Planning and Housing gave a response to statement requested by Hon. Hashim Kamau regarding the breach of the terms spelt out in the free-hold lease between the defunct Nairobi City Council, now the Nairobi County Government and the Gospel Fellowship Church regarding the plot LR NO.36/VII/117; a road reserve.
- c) The Chairperson of the Sectoral Committee on Planning and Housing gave a response to statement requested by Hon. Hashim Kamau regarding the allocation of spaces within City Hall and its Annex to Commercial banks.
- d) The Chairperson of the Sectoral Committee on Planning and Housing gave a response to statement requested by Hon. David Mberia regarding the grabbed land plot LR. Number 1159/70 belonging to Karen Health centre by PCEA Church Karen Ward.
