3. COMMUNICATION FROM THE CHAIR

The Speaker conveyed the following Communication -

Hon. Members, we want to welcome the Hon. Deputy Speaker of the County Assembly of Nairobi and the Hon. Members who just came in from a very successful tour on duty in the United States of America, Colorado Denver City.

Hon. Members, there was an item that was raised on the issue of suspension of Hon. Charles Thuo Wakarindi MCA Dandora area III Ward. The final communication will be done tomorrow 2:30 pm. Hon. Members, there have been issues of very serious nature raised in regard to the Hon. Members of this House and as from tomorrow 2:30 p.m. the Sergeant-At-Arms is under instruction that no drinks will be allowed to this Hon. House unless provided for by the Sergeant-At-Arms or members of the staff of the Clerk. I don't want to go into details, but I want to give a straight warning; straight warning. 4. NOTICE OF MOTION - (Hon. Peter Imwatok)

THAT, aware that the Transition Authority under Legal Notice No. 177 provided for the transfer of the county transport function including county roads, mechanical and transport equipment and public road transport to county governments; concerned that this function is yet to be transferred despite Nairobi City County's compliance with all the pre-requirements and having 37 certified engineers; noting that the Fourth Schedule of the Constitution (2010) supports the devolvement of this function, this Assembly resolves that the Transition Authority should immediately undertake all the necessary measures to ensure the transfer of the county transport function to the Nairobi City County Government.

5. STATEMENT PURSUANT TO STANDING ORDER 41(2)(C)

The following Members sought Statements -

- i. The Hon. Kamau Thuo requested a statement from the Chairperson of the Sectoral Committee on Labour and Social Welfare regarding the advertisement of the position of Director of Human Resource Management by the Nairobi County Public Service Board. The chairperson was asked to inquire into and report on:
 - a) reasons for re-advertisement of the position of the Director of Human Resource Management;
 - b) table a list of all applicants and the shortlisted applicants for the above mentioned post;

- c) table a list of all appointments done by the Public Service Board since inception;
- ii. The Hon. Hashim Kamau requested a statement from the Chairperson of the Sectoral Committee on Transport and Public Works regarding the state of elevators (lifts) in City Hall Annex. The chairperson was asked to inquire into and report on:
 - a. Whether the Executive in charge is aware of the state of these elevators; and
 - b. What corrective measures have been put in place to comply with the Constitution (2010), building regulations and avert a disaster.
- iii. The Hon. Wilson Ochola requested a statement from the Chairperson of the sectoral Committee on Culture and Community Service regarding the manpower of the Nairobi City County Fire Station and its branches. The Chairperson was asked to inquire and report on:
 - a. the number and qualification of staff working in the fire station and its branches:
 - b. possibility of recruiting new members and specifically from the National Youth Service and promotion of current staff's on merit;
 - c. if the members working in the fire station are insured and have medical assistance or clinic within their premises, to handle first aid and other emergencies to the staff;
 - d. possibility of having stake holders like Kenya Red Cross to be stationed within the station, that will work towards addressing disaster management and first aid when necessary;
