The Speaker conveyed the following communication from the Chair:-

— REORGANIZATION OF THE PLANNING & HOUSING COMMITTEE

"Honourable Members,

The Chair has on several occasions spoke about the need to uphold high standards of personal conduct when within the Assembly precincts, whether in plenary or in Committee meetings.

Indeed, the Chair even received communication from the Ethics and Anti-Corruption Commission that raised concerns regarding the conduct of Members of the County Assembly during debate in the County Assembly, which fall short of the prescribed standards of conduct for holders of Public Office under Chapter Six of the Constitution of Kenya and Part II of the Leadership and Integrity Act, No. 19 of 2012.

Hon. Members, you are aware that Committees are an extension of the Assembly and therefore subject to the rules and regulations that guide our operations. However, there seems to be little appreciation of this fact amongst some Members in light of their conduct during committee sittings.

Today, Hon. Members, I wish to address emerging, serious privilege issues that have arisen in the Sectoral Committee on Planning and Housing and threaten to derail its proper functioning. The Sectoral Committee on Planning and Housing is subject to House rules and procedures, and so is its Membership from across the political divide.

Hon. Members, Section 9 of the National Assembly (Powers and Privileges) Act, provides that the Speaker may, from time to time as he deems expedient, issue directions in the form of a Code of Conduct regulating the conduct of members of the Assembly whilst within the precincts of the Assembly other than the Chamber.

Hon. Members, the Chair will not allow Committees to be turned into havens of misconduct and abuse of privileges and immunities. The Chair takes great exception to this development and will not tolerate Members hell bent on derailing the work of Committees.

I therefore wish to direct that the Leader of Majority and the Leader of the Minority move with speed and re-constitute the Sectoral Committee on Planning and Housing forthwith.

It is so directed.
