THAT, aware that Standing Order 21 allows the Senator of the County or a visiting Governor or other such visiting dignitary, to address the County Assembly on such occasions as may be appropriate; further aware that Article 96 (1) of the Constitution provides that the Senate represents the counties, and serves to protect the interests of the counties and their governments; deeply concerned that the Senate has in recent months passed legislation that is contrary to the spirit and letter of Article 96 (1) of the Constitution, for instance the creation of the County Development Board and amendments to enforce ceilings on expenditure of County Assemblies, which threatens to derail the proper execution of County Government functions as envisioned by the Constitution and all enabling statutes, this Assembly resolves to invite the Senator of the Nairobi City County pursuant to Standing Order 21 to address the Assembly on the challenges facing the County and the Senate's efforts to address them, especially with relation to legislation affecting operations of Counties.
