Honorable Members, I have the following communication to make.

— **BURSARY STATUS**

“Honourable Members,

We have received a list of bursary allocation to a number of 46 wards as at 4<sup>th</sup> August, 2014. The list contains the amount allocated to each ward and the status of the allocation.

I have therefore directed the respective department to compile the bursary list of all wards within the Nairobi City County Assembly so as to release them at once and not in bits.

Furthermore, I wish to notify the Honourable Members to hold on for a while as the relevant Committee pursues the department to complete the task as soon as possible.

This is therefore to call upon all the members of the County Assembly to refrain from picking the forms individually as it will compromise the work of the Committee.
