### 3. COMMUNICATION:-

The Speaker conveyed the following Communications:-

## **GROSSLY DISORDERLY CONDUCT**

Hon. Members, you will recall that on Monday 29th June, 2015, there was a scuffle involving two Members during plenary proceedings of the County Assembly.

The Hon. Maurice Akuk, MCA, then addressed the Assembly and alleged that he had been slapped by the Hon. Alfred Ambani, MCA.

The Chair then committed to issue a report on the matter after investigations.

I wish to report as follows.

Hon. Members, the regulation of conduct and breach of order in the Assembly is provided for by Standing Order 104, 105, 106, 107.

From investigations, the Chair has established that the Hon. Alfred Ambani conducted himself disorderly, contrary to Standing Order 104(1)(c). The Member in question conducted himself unnecessarily aggressively, to the detriment of order and the peaceful conduct of business.

Hon. Members, I wish to remind you that Standing Order 104 (2) provides as follows -

The Speaker or the Chairperson of Committees shall order any Member whose conduct is grossly disorderly to withdraw immediately from the precincts of the County Assembly-

(a) on the first occasion, for the remainder of that day's sitting;(b) on the second or subsequent occasion during the same session, for a maximum of three sitting days including the day of suspension,

(3) If on any occasion the Speaker or the Chairperson deems that his or her powers under this Standing Order are inadequate, the Speaker or the Chairperson may name such Member or Members, in which event the procedure specified in Standing Order 105(Member may be suspended after being named) shall be followed.

Hon. Members, the subsequent procedure for naming a Member is clearly detailed under the said Standing Order 104(3) and 105.

Hon. Members, I wish to note that this incident was very unfortunate. The Chair takes threats of violence against any Member seriously and will not hesitate to take extreme measures to ensure it does not happen.

Indeed as is the case elsewhere in ordered societies, grossly disorderly conduct has no place in the County Assembly. The foregoing is the case for knowingly raises a false point of order; persistently making serious allegations without, in the Speaker's opinion, adequate substantiation and any form of misconduct. Hon. Members, Standing Order 104 (3), (3) provides that *if on any* occasion the Speaker or the Chairperson deems that his or her powers under this Standing Order are inadequate, the Speaker or the Chairperson may name such Member or Members, in which event the procedure specified in Standing Order 105 (Member may be suspended after being named) shall be followed.

Hon. Members, you have been warned. The honor is on all of us to ensure we conduct ourselves in a manner that fosters tranquility and the orderly conduct of business.

Hon. Members, the Hon. Ambani is a diligent and valiant Member of this County Assembly. The Chair therefore will let this serve as a warning.

Hon. Ambani, apologize and desist in future from occasioning such serious breaches of order.

## **GUESTS ENTRANCE TO ASSEMBLY PRECINCTS**

Hon. Members, the Speaker appreciates that Members often have visitors who call on them at the Assembly for various matters. Indeed the Chair has directed before that proper measures be taken to ensure thorough screening of visitors in light of the very existent threat of terrorism the Assembly faces.

Further to my earlier directions, I wish to communicate as follows.

Henceforth, I direct that all guests to the Assembly access the precincts via the main entry opposite KICC. Upon inquiry at the entry, the Seargent at Arms shall coordinate with the Member whose guests he will be serving before permitting entry. Members are at will to visit with their guests at the lobby, next to the Restaurant. Entry into the precincts shall be strictly limited due to security reasons.

Sergeants at arms are directed to ensure no unauthorized guests access the Assembly via the back entry, strictly.

It is so ordered.

## CONCLUSION OF PENDING STATEMENTS

Honorable Members, the Chair has on several occasions reminded Members and Chairpersons of pending statements and the need to expedite their conclusion. Yesterday, I committed to follow up on the matter and report back today.

I wish to communicate as follows.

Hon. Members, for the Second Session, the Chair has leanrt that we still have ten pending Statements.

For the third Session, there are ten inadequate responses, ten pending and 89 responses has been received and given, while seven are awaiting Tabling.

Details of the same are attached to this Communication. I hereby direct that all the pending Statements from the Second Session be dispensed with by Tuesday, 21<sup>st</sup> July, 2015 failure to which the Select Committee on Implementation will take up this matter and report back to the Assembly on the sanctions to be imposed on the defaulting Committees and County Executive Committee Members.

The chairs are therefore advised to expedite conclusion of all pending Statements and report on Tuesday, 21<sup>st</sup> July, 2015.

The Chair commits to follow up on the forgoing and will report again on 21<sup>st</sup> July, 2015.
