QUORUM OF THE ASSEMBLY

There being no Quorum at the commencement of the sitting the Chairperson of Committees (Hon. Kennedy Ng'ondi) caused the Division bell be rung for Ten minutes.

Notification of rejection of County Chief Officer, Information, Communication and e-Government

Please refer to your letter Ref: NCCASM/001104/015 date 19th October 2015 notifying me of the County Assembly rejection of Kennedy Okong'o to the position of Chief Officer Information, Communication and e-Government. I do not find merit in the reason given for the rejection. I am therefore appealing to the County Assembly to reconsider its position and approve the proposed appointment. Thank you.

Hon. Members, I now direct that the Sectoral Committee on Justice and Legal Affairs to proceed with the vetting of the said nominee for the Chief Officer responsible for Information, Communication and e-Government and table a report on Tuesday, 1st December 2015."

Upon delivery of the message, several members stood on a point of order objecting the message conveyed by the Speaker. The speaker then withdrew the statement and ordered the Speakers panel to meet on Friday, 27th November, 2015 and deliberate on the matter."
