SECTORAL COMMITTEE ON JUSTICE AND LEGAL AFFAIRS**

**Hon. Members**, yesterday the Nairobi City County Assembly resolved to remove the acting County Secretary from the office following the Minority Leader's motion pursuant to standing order No. 30.

**Hon. Members**, Committee as are an extension of the Assemblies and in that regard it can never work in isolation.

**Hon. Members**, it is indeed laughable for the Committee to purport that it is independent and free from the resolutions of the House. The Sectoral Committee on Justice and Legal Affairs today at its meeting with the County Secretary and Attorney, disregarded the Assembly resolution which is in contempt and misdirection.

**Hon. Members**, since the Committee was made aware of the same communication and disregarded the same. In that regard, I have decided to revoke standing order no. 1 and disband the Sectoral Committee of Justice and Legal Affairs and that the same be reconstituted with deferent Members.
