### 3. COMMUNICATION FROM THE CHAIR

The Speaker conveyed the following communications from the Chair:-

### **ISSUANCE OF WATER TANKS**

"Honourable Members, I have the following communication to make – Hon. Members, you will recall that the County Executive proposed the sum of Kshs.3 million for Water-related projects ranging from boreholes, water tanks, water Kiosks/points, sewage lines and water materials (such as pipes) for each County Ward. Subsequently, Hon. Members, I am pleased to inform you that the first batch of Water Tanks will be rolled out today 5th July, 2016.

Hon. Members, this is therefore to inform Members who had selected tanks as their preferred water related project to prepare a list of beneficiaries and forward the same to the Chairperson of the Sectoral Committee on Water and Sanitation for endorsement and onward transmission to Mr. Mario Kainga, Director of Water and Sanitation whose office is at City Hall Annexe, 4th Floor.

It is so directed.

# <u>CLARIFICATIONS ON FUNDING OF THE COUNTY ASSEMBLY -</u> FINANCIAL CASH FLOWS

Honorable Members, on the 16<sup>th</sup> of March, 2016, the Chair gave a communication in which he decried the erratic disbursement of funds by the County Treasury to the County Assembly, and its effect on the roll out of Assembly programs.

Hon. Members, the Chair had then directed that in order to solve the problem once and for all, all business emanating from the County Treasury be suspended until a commitment is received from the County Treasury on modalities for disbursement of monies owed to the Assembly, namely gratuity and other expenditure sums."

Hon. Members, consequently, the CFSP and Supplementary Budget Estimates were not tabled as directed until the stalemate is conclusively resolved. An earlier letter dated 11th March, 2016 was written to the Governor communicating the challenges of erratic disbursement of funds for the month of February, 2016, where the County Assembly had requested for the sum of Kshs250 million, being monies for recurrent expenditure, development expenditure, gratuity, transfers and mortgages.

Hon. Members, the said letter indicated that the County Treasury had paid the sum of Kshs113 million creating a shortfall of Kshs137 million. It was on the basis of the foregoing deficit that the Chair had earlier suspended the consideration of any business from the County Treasury.

Hon. Members, subsequently, the County Executive Committee (CEC) member for Finance and Economic planning, Mr. Wainana and Mr. Gatimu were invited for a meeting at the Assembly Precincts, during which an undertaking was made by the County Treasury to give the Assembly Kshs50 million for gratuity, and the balance of Kshs62.4 million to be disbursed by end of April 2016. The foregoing was communicated by the CEC finance in a letter dated 17th March, 2016 and payments to that effect of Kshs50 million made, with a balance of 62.4 million outstanding.

Hon. Members, it's on the basis of the foregoing commitment that the Chair subsequently lifted the suspension imposed on business from the County Treasury. Since then however, the Assembly has not received the outstanding balance from the County Treasury.

Hon. Members, in a letter by the Clerk of the County Assembly dated 27<sup>th</sup> June, 2016, the County Assembly tabulated all outstanding amounts owed up to end of June, 2016 to Kshs299 million, which included Kshs78 million recurrent expenditure, 62.4 million gratuity, Kshs40 million Car Loan Scheme and Kshs118 million development expenditure.

Hon. Members, the owed amount has since been reconciled and as of today, the County Treasury has not remitted the sum of Kshs238 million as outstanding disbursements, of which Kshs62.4 million is for gratuity, Kshs78 million for recurrent expenditure and Kshs53 million for development. The foregoing explains the delays in payment of salaries.

Hon. Members, as the Chair of the County Assembly Service Board (CASB), I am deeply disturbed by misleading information emanating from the CEC Finance and Economic Planning that monies for gratuity were remitted in 2014 to the County Assembly, yet the said CEC Member in a letter dated 29<sup>th</sup> April, 2016 undertakes to remit arrears of gratuity at Kshs62.4 million by end of the budget cycle.

Hon. Members, this misinformation by officers who have willfully refused to fulfill their obligations and fund the Assembly is highly regrettable and irregular.

Hon. Members, it should therefore be noted for clarity that at the end of the 2015/2016 Financial year, the County Treasury owed the County Assembly the sum of Kshs238 million in pending disbursements for various line items as highlighted variously, elsewhere in this communication. As such, I leave it to Honourable Members to decide the next best course of action with regard to these matters. Hon. Members, the Chair can only do so much.
