4. NOTICE OF MOTION – *(Hon. Alex Otieno, MCA)*

THAT, aware that the Nairobi City County has the potential to collect revenue upwards of Kshs 4 billion per month as demonstrated by the Governor during a recent breakfast meeting with Members of the County Assembly; noting that the Nairobi County e-payment system, the first cash-light system for a county government in Kenya, is yet to make significant impact due to man-made leakages at collection points; deeply concerned that the continued revenue leakage at various collection points is mostly through theft or inaction by County Employees charged with overseeing collection at those points; recognizing that some

employees within the revenue collection chain have overstayed their deployment at specific postings, thus possibly building cartel like networks that protect and promote the leakage and wastage; this Assembly urges the County Executive to transfer with immediate effect employees in the revenue collection chain who have stayed at a posting for at least three years and adopt such practice going forward to prevent the formation of cartel like revenue leakage avenues by County employees.
