The Deputy Speaker conveyed the following Communication from the Chair;

"Hon. Members, I have the following communication to make.

#### FORWARDING AND TABLING OF CFSP IN THE COUNTY ASSEMBLY

Hon. Members, as you are aware, the Public Finance Management Act, 2012, under Section 117 (1) provides that the County, Treasury shall prepare and submit to the County Executive Committee the County Fiscal Strategy Paper for approval and the County Treasury shall submit the approved Fiscal Strategy Paper to the county assembly, by the 28<sup>th</sup> February of each year.

Consequently, the Assembly received the County Fiscal Strategy Paper on Friday 26<sup>th</sup> February, 2016.

I wish to guide as follows regarding the tabling of the County Fiscal Strategy Paper, 2016 –

Hon. Members, the Assembly has written to the CEC Member for Finance and Economic Planning regarding a marked reduction in the County Assembly's proposed expenditures as contained in the submitted CFSP.

The CFSP sums up the amounts allocated for goods and services and transfers to County Assembly Funds as "other recurrent" and given the amount of Kshs803M.

Hon. Members, the total amounts for the items according to the Assembly's earlier submissions was Ksh944M. The CFSP has therefore reduced County Assembly proposals by kshs144M.

As such, it is impossible to infer which category of the expenditure was reduced. Further, it is difficult to account for which Assembly programs might be affected in light of the generalized reduction.

Subsequently, Hon. Members, the CFSP will not be tabled today in order to allow for further consultation with the CEC Member for Finance and Economic Planning on the aforesaid reduction.
