**QUORUM OF THE ASSEMBLY**

The Member of the Speaker's Panel (Hon. Samuel Nyang'wara) having confirmed that there was no Quorum caused the Bell to be rung for Ten minutes.

There being no Quorum at the expiry of the ten minutes, the bell was rung for further five minutes.

There being a Quorum at the expiry of the five minutes, the Hon. Nyang'wara called the Assembly to order.

**3. STATEMENT PURSUANT TO STANDING ORDER 41(2)(C)**

Rising in her place on order 6, Hon. Mrion Githinji gave a notice of Motion for the adjournment of the Assembly under the provisions of Standing Order 30 in order to discuss a definite matter of County importance regarding health care services including the ongoing medics' strike.

And there being sufficient number of Members rising in their places in support of the notice;

Thereupon, Hon. Nyang'wara directed that the Motion be moved after Order No.9.

**5. MOTION - (DRILLING OF PUBLIC BOREHOLES IN THE 85 WARDS**

**Motion made and Question proposed;**

**THAT**, aware that Article 43 (1) (d) of the Constitution of Kenya, 2010 states that every person has a right to clean and safe water in adequate quantities; further aware that paragraph 11 (b) of the Part Two of the Fourth Schedule to the Constitution stipulates that County Government is to provide County public works and services including water and sanitation services; concerned that most parts of the County especially informal settlements lack clean, safe, sufficient and affordable water, which has led to introduction of untreated water supply businesses within the County; acknowledging that the Nairobi City Water and Sewerage Accompany has continuously rehabilitated various sources of its water to ensure clean and adequate water supply; noting that the increasing population in the County implies increasing demand for basic amenities such as water supply, this Assembly urges the County Executive to drill public boreholes in all the 85 Wards to ensure availability of adequate, clean and safe water for the residents of Nairobi City County.

**6. ADJOURNMENT OF THE ASSEMBLY UNDER STANDING ORDER NO.30 TO DISCUSS A MATTER OF DEFINITE COUNTY IMPORTANCE REGARDING THE CHALLENGE OF HEALTH CARE SERVICES INCLUDING THE ONGOING MEDICS' STRIKE**

**Motion made and Question proposed,**

**THAT**, aware that Article 43 (1) (a) of the Constitution of Kenya (2010) states that every person has the right to highest attainable standards of health including the right to health care services; further aware that pursuant to paragraph 2 of Part 2 of the Fourth Schedule to the Constitution, the County Government is mandated to promote primary health care including county health facilities; concerned that the ongoing strike by doctors across the County has paralyzed delivery of services in the county health facilities, thus infringing to the right to health care by residents of the County; acknowledging that the issue of medics have been on strike in different occasions due to various factors such as lack of salary even up to six months, this Assembly adjourns pursuant to Standing Order 30 to discuss the challenge of health care services including the ongoing medics' strike as a matter of definite urgent County importance.
