MOTION – HON. KENNEDY OYUGI ODHIAMBO, MCA

Subject: Re-introduction of disbursement of bursaries through cheques

THAT, aware that since the establishment of the county governments in 2013, the Nairobi City County Government has set aside a certain amount of money in the budgets to help the needy and yet bright students to access education through the bursary programmes, where such students apply for this bursaries and they are disbursed to their schools' accounts by the County Government, this has enabled many students to access education across the County; further aware that the County Government resolved to use Electronic Fund Transfer in disbursing bursaries instead of using cheques with the view to address the problems experienced in the past where funds meant for needy students went into wrong hands; concerned that introduction of vouchers in disbursement of bursaries has faced a series of challenges where monies deposited in various schools' accounts could not be verified by the County Accounts Department due to the discrepancies between the vouchers and the electronic transfer system; further concerned that various Schools have received the County monies without clear accountability records, this Assembly urges the County Executive to re-introduce the use of cheques in disbursement of funds which is reliable and dependable compared to the voucher system.

A. <u>MOTION – HON. PATRICK MBANGULA MUSILI, MCA</u>

Subject: Development of a Nairobi City Electric Light Rail Transit System.

AWARE that the Electric Light Rail Transit System as a medium capacity mode for mass rapid transport has been embraced by modern Cities in the world as a convenient and eco-friendly mode of urban transport system with its greatest benefits being; -

- i) Reduce traffic congestion in the City;
- ii) Reduction of pollution in the City due to its electric functionality;

iii) increasing property values and fostering economic development; and,

iv) Provision of affordable and reliable means of transportation

> APPRECIATING that Addis Ababa, Ethiopia is one of the Cities in Africa to install and commission a 17 Kilometers Light Rail Transit Line on 20th September 2015, running from Northern part of the city to its industrial areas in the south and a second 14.6 Kilometers Light Rail Transit Line running from the east to west of Addis Ababa City commissioned on the 9th of November 2015, with a total length of 31.6 Kilometers and with a total of 39 stations; ACKNOWLEDGING the provision of Article 189 of the Constitution of Kenya 2010 which provides for cooperation between the National and County Governments, particularly, 189 (1) (a) which states that Governments at either level shall, inter-alias, assist, support and consult and, as appropriate, implement the legislation of the other level of government; FURTHER ACKNOWLEDGING the provision of Article 189 (2) which provides that Governmentat each level, and different governments at the county level, shall cooperate in the performance of functions and exercise of powers and, for that purpose, may set up joint committees and joint authorities. NOTING the need for top-bottom co- ordination by the National Government and the County Government as provided for in Article 189 of the Constitution of Kenya, 2010 through multi-agency technical Committee approach; NOW THEREFORE, this Assembly RESOLVES that the County Executive initiates a multi-agency technical Committee from the following agencies:

- i) Representative from the Ministry of Transport and Public Works;
- ii) Representative from the Ministry of Planning and National Development
- iii) Representative from the Ministry of Finance and Economic Planning
- iv) Representative from the Kenya Railways;
- v) Representative from the National Transport and Safety Authority (NTSA)
- vi) Representative from the Nairobi Metropolitan Service (NMS),
- vii) The County Secretary, Nairobi City County;
- viii) Representative from Kenya Urban Roads Authority;
- ix) Representative from the Kenya National Chamber of Commerce Nairobi County
- x) Representative from the Nairobi Metropolitan Area Transport Authority (NaMATA),
- xi) Two (2) experts from a reputable firm dealing with light railway system;
- xii) Two (2) persons representing stakeholders that the County Executive to Committee;

With the following Terms of Reference, namely to: -

- 1. Undertake an Economic feasibility Study to determine the cost-benefit analysis of an Electric Light Rain Transit System in Nairobi City County;
- 2. Undertake a Technical feasibility Study for anticipatory establishment of an Electric Light Rain Transit System in Nairobi City County against the required resources;
- 3. Undertake an Operational feasibility Study to determine if the county needs would be met by the proposed project; and



4. Report to the County Assembly with a Comprehensive Report within Four (4) months from the date of establishment of the Technical Committee on the reliability, sustainability and viability of the proposed project.

Subject: Establishment of cooling plants for promotion of aquaculture – fish farming.

AWARE THAT Part 2 of the Fourth Schedule of the Constitution of Kenya provides for the functions of for the County Government, as the case with Paragraph 1 (e) which dictates Agriculture including but not limited to fisheries as one of the County Functions; COGNIZANT that the National Government's Big 4 Agenda seeks to foster economic development and provide a solution to the various socio-economic challenges through the following four economic pillars;- Food Security and Nutrition, Affordable Universal Health Care, Affordable Housing and Enhancing Manufacturing; NOTING that the United Nations General Assembly declared 2022 the International Year of Artisanal Fisheries and Aquaculture with Food and Agriculture Organization of the United Nations (FAO -UN) as the lead agency for celebrating the Year in collaboration with other relevant organizations and bodies of the United Nations system by recognition of the millions of small-scale fishers, fish farmers and fish workers who provide healthy and nutritious food to billions of people and contribute to achieving Zero Hunger; FURTHER **NOTING** that in Kenya, the Ministry of Agriculture, Livestock and Fisheries 2015 Status Report on fisheries observed that fisheries development in the Country was slow due to a number of obstacles, being but not limited to lack of proper information on aquaculture development, cultural variations that do not support fish farming, uncertainties on returns on investment, lack of political good will, low investment by Kenyans in the sector, high running cost and lack of access to high quality fingerlings; ACKNOWLEDGING that Kenya has a high potential for fish farming as it can offer prospects for sustainable food security and income for communities hence creation of employment; this ASSEMBLY RESOLVES that the Nairobi Metropolitan Services (NMS) in conjunction with County Executive;-

- i) Installs four (4) industrial ice plant for fish preservation in the 4 main parts of the County and such plans be considered in the Budget for FY 2021/2022 that would promote aquaculture in the County; and,
- ii) Develop a program for promotion of fish farming among the youth through provision of **FREE** fingerlings be considered in the FY 2021/2022 budget.
