Subject: Adoption of a Report

THAT this Assembly adopts THE REPORT OF THE SELECT COMMITTEE ON DELEGATED COUNTY LEGISLATION ON CONSIDERATION OF THE KENYA GAZETTE SUPPLEMENT NO. OF 2021 (THE PUBLIC FINANCE MANAGEMENT –NAIROBI CITY COUNTY BURSARY AND SCHOLARSHIP FUND, REGULATIONS, 2021) tabled in the Assembly on Tuesday, 28th September 2021.

MOTION – HON. WAITHERA CHEGE, MCA

Subject: Development of the County programs on countering violent extremism in the County

THAT, aware that Part Two of the Fourth Schedule to the Constitution provides for the functions of the County Government which include ensuring and coordinating the participation of communities and locations in governance at the local level and



assisting communities and locations to develop the administrative capacity for the effective exercise of the functions and powers and participation in governance at the local level; further aware that Kenya continues to face violent extremism by radical militarist groups, especially in areas along in Nairobi where drivers of violent extremism are localized and depend on the sociopolitical landscape of the communities which serve as recruitment hubs; **concerned** that a majority of young people in Nairobi have high hopes and ambitions, however, poor macroeconomic performance, a lack of labor market opportunities, an education system that suffers from problems of access, quality, and relevance, and a society that negates the self-expression of young people mean that many young people are unable to translate their aspirations into a productive and fulfilling future; **further concerned** that high expectations, disappointing employment and life prospects, and marginalization among young people fuels frustration and desperation to the advantage of drivers of violent extremism who recruit such youth; **noting** that hard military and security approaches used by the National Government have not successfully and completely addressed the threat of violent extremism especially in Nairobi City County which has the highest rate of inequality that exists between young community members and community leaders in urban settlements, this Assembly urges the County Executive in partnership with local stakeholders such as community and faith based organizations:-

- a) develop programs that address poverty and unemployment by incorporating vulnerable and at-risk groups in such programs; and
- b) develop programs that identify and empower trusted influencers with the skills and tools they need to provide concrete solutions to help at-risk individuals in their surrounding which makes them feel that they have more options than turning to a violent extremist groups, and allow for more information sharing and coordination of strategies in preventing violent extremism in the County.

MOTION – HON. MARK MUGAMBI, MCA

Subject: Interventions to prohibit PSV operators from terminating at petrol stations

THAT, aware that Article 46 of the Constitution of Kenya 2010 provides that consumers of goods and services have a right to protection of their health, safety and economic interests; **COGNIZANT THAT** passengers aboard public service vehicles enjoy the rights to safety under statutes as it is under the Constitution including Section 27 of Nairobi City County Transport Act, 2020 which prohibits PSVs from picking and dropping passengers at undesignated bus stops; and Section 33 (g) of the Act prohibits PSVs not reaching the final destination and other actions that endanger the lives of passengers; **NOTING THAT** Section 11(g) of Energy Act mandate the Energy and Petroleum Regulatory Authority (EPRA) to formulate, set, enforce and review environmental, health, safety and quality standards for the energy sector in coordination with other statutory authorities including requiring fuel dispensing to safeguard against fire accidents; **CONCERNED THAT** petrol stations are areas that store and sell highly flammable substances including petrol and Liquefied Petroleum Gas (LPG) that are susceptible to explosion unless necessary safety steps are taken by operators, consumers and passenger vehicles; **OBSERVING THAT** public transport vehicles have continued to violate public transport regulatory frameworks as well as safety standards for passengers by establishing and utilizing petrol stations as pick and drop terminals hence endangering



lives of passengers despite safety signs and symbol placed by petrol station operators in accordance with the established regulatory frameworks. This Assembly urges the County Executive and the Nairobi Metropolitan Services to:

- 1) Issue a public notice prohibiting Public Transport Vehicles (PSVs) from terminating at petrol stations for picking and dropping of passengers; and
- 2) Formulate regulations to Nairobi City County Transport Act, 2020 forthwith to provide for punitive measures for operators who use petrol stations as termini.

Subject: Renaming of Mbagathi Way after Rt. Hon. Raila A. Odinga.

THAT, aware that the Country has a history of conferring honors and recognition on its most outstanding citizens for their service, acts or deeds which promote public good; **NOTING** that this tradition has historically been done by both the National government and the then County or Municipal Councils, which now are County Governments; **COGNIZANT** that these honors and recognition has extended to not just medals and titles, but the renaming of roads and other public facilities after our heroes and heroines and other valiant Kenyans; **OBSERVING** that the **Rt. Hon. Raila Amollo Odinga, EGH** has for the entire period of his adult life greatly impacted in the development of the Kenyan State both democratically and economically; and has during this period been involved in fighting for greater democratic space, good governance, rule of law and development of infrastructure against many odds including detention without trial for ten years ; **NOTING** that in 2005, as the Minister for Roads and Public Works, Raila Odinga conceived, planned and implemented masterpiece infrastructure such as the Thika Super Highway and the Mbagathi way concrete road which has since proved to be the most durable road ever constructed in Kenya; **GRATEFUL** that his recent actions of shaking hands with both the former President H.E. President Mwai Kibaki, EGH and H.E. President Uhuru Kenyatta, EGH led to restoration of peace and harmony in Kenya; **RECOGNIZING** that in recognition of these decades of service, the African Union (AU) recently appointed him as the African Union High Representative for Infrastructure Development; **NOW THEREFORE**, this Assembly **RESOLVES** that the Nairobi City County Government rename **Mbagathi Way** in Kibra Constituency, Nairobi City County to **Raila Odinga Way** in recognition of Rt. Hon. Raila Amolo Odinga's contribution in the development and growth of the Kenyan State including his selfless sacrifice in championing for good governance, democratic space and development of infrastructure for the period of his entire adult life.
