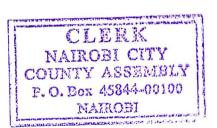

THE NAIROBI CITY COUNTY SUPPLEMENTARY APPROPRIATION (NO. 2) ACT, 2023

Date of Assent: 18th May, 2023

Date of Commencement: 19th May, 2023

AN ACT of the Assembly of Nairobi City County to authorize the issue of a sum of money out of the County Revenue Fund and its application towards the service of the year ending on the 30th June, 2023 and to appropriate that sum and a sum voted on account by the Nairobi City County Assembly for certain public services and purposes

ENACTED by the Nairobi City County Assembly, as follows—**Short title.**

1. This Act may be cited as the Nairobi City County Supplementary Appropriation (No. 2) Act, 2023.

Issue of KSh. 39,363,916,280 out of the County Revenue Fund for public services and purposes of the year ending 30th June, 2023 and appropriation of the money granted

- 2. (1) The County Treasury may issue out of the County Revenue Fund and apply towards the supply granted for the service of the year ending on the 30th June, 2023, the sum of Kenya Shillings Thirty-Nine Billion, Three Hundred Sixty-Three Million, Nine Hundred Sixteen Thousand, Two Hundred Eighty only and that sum shall be deemed to have been appropriated as from 1st July, 2022, for the services and purposes specified in the Schedule annexed hereto.
- (2) The sum granted out of the County Revenue Fund by subsection (1) as authorized by the Nairobi City County Assembly on the 18th May 2023, in accordance with Article 224 of the Constitution.
- 3. In addition to the sum granted by section 2, there may be applied, for the services and purposes specified in the Schedule, the sums specified out of any money directed to be applied as Appropriations in Aid under Article 206(1)(b) of the Constitution.

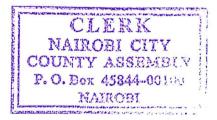

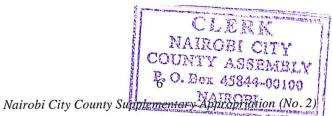
