THE NAIROBI CITY COUNTY APPROPRIATION ACT, 2024

No. 3 of 2024

Date of Assent: 27th June, 2024

Date of Commencement: 24th July, 2024

AN ACT of the Nairobi City County Assembly to authorize the issue of a sum of money out of the County Revenue Fund and its application towards the service of the year ending on the 30th June, 2025 and to appropriate that sum and a sum voted on account by the Nairobi City County Assembly for certain public services and purposes

ENACTED by the Nairobi City County Assembly, as follows—

Short title

1. This Act may be cited as the Nairobi City County Appropriation Act, 2024.

Issue of KSh. 43,213,266,834 out of the County Revenue Fund for public services and purposes of the year ending 30th June, 2025 and appropriation of the money granted

2. (1) The County Treasury may issue out of the County Revenue Fund and apply towards the supply granted for the service of the year ending on the 30th June, 2025, the sum of **Kenya Shillings 43,213,266,834 (Forty-Three Billion, Two Hundred Thirteen Million, Two Hundred Sixty-Six Thousand, Eight Hundred and Thirty-Four only)** and that sum shall be deemed to have been appropriated as from 1st July, 2024, for the services and purposes specified in the Schedule annexed hereto.

(2) The sum granted out of the County Revenue Fund by subsection **(3)** as authorized by the Nairobi City County Assembly on the 26th June, 2024, in accordance with Article 224 of the Constitution.

3. In addition to the sum granted by section 4, there may be applied, for the services and purposes specified in the Schedule, the sums specified out of any money directed to be applied as Appropriations in Aid under Article 206(1)(b) of the Constitution.
