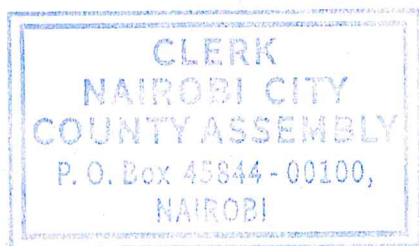

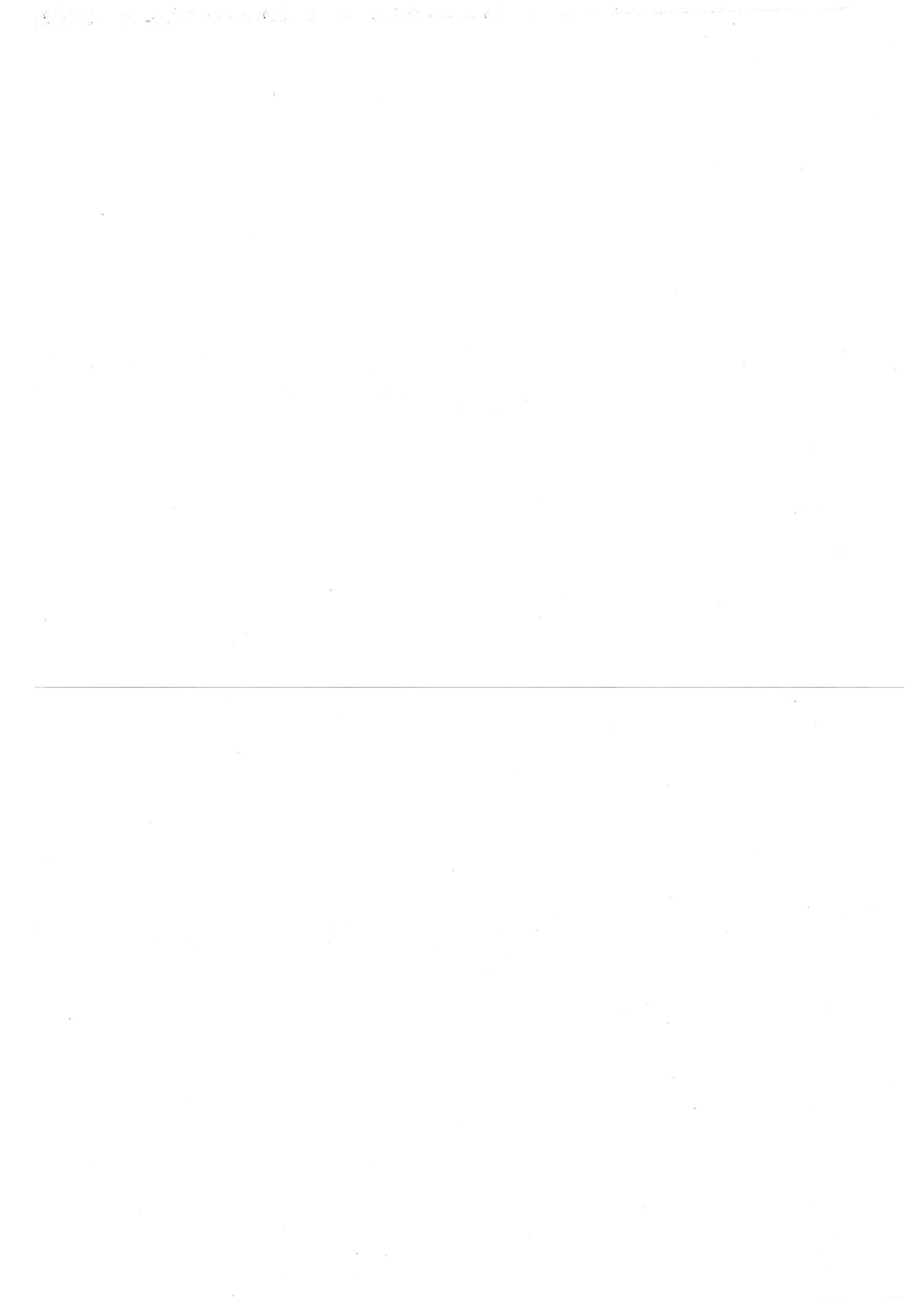

THE NAIROBI CITY COUNTY APPROPRIATION ACT, 2026

No. 3 of 2026

Date of Assent: 31st July, 2026

Date of Commencement: 1st July, 2026

AN ACT of the County Assembly of Nairobi City to authorize the issue of a sum of money out of the County Revenue Fund and its application towards the service of the year ending on the 30th June, 2027 and to appropriate that sum and a sum voted on account by the Nairobi City County Assembly for certain public services and purposes

ENACTED by the County Assembly of Nairobi City, as follows—

Short title.

1. This Act may be cited as the Nairobi City County Appropriation Act, 2026.

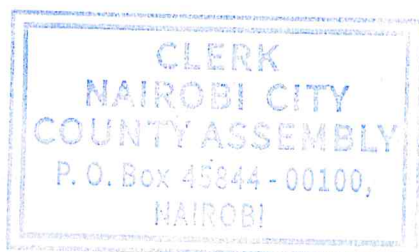
Issue of KSh. 48,736,764,291 out of the County Revenue Fund for public services and purposes of the year ending 30th June, 2027 and appropriation of the money granted

2. (1) The County Treasury may issue out of the County Revenue Fund and apply towards the supply granted for the service of the year ending on the 30th June, 2027, the sum of **Kenya Shillings Forty-Eight Billion, Seven Hundred and Thirty-Six Million, Seven Hundred and Sixty-Four Thousand, Two Hundred and Ninety-One Only** and that sum shall be deemed to have been appropriated as from 1st July, 2026, for the services and purposes specified in the Schedule annexed hereto.

(2) The sum granted out of the County Revenue Fund by subsection (1) as authorized by the Nairobi City County Assembly on the 28th July, 2026, in accordance with Article 224 of the Constitution.

Appropriations in Aid

3. In addition to the sum granted by section 2, there may be applied, for the services and purposes specified in the Schedule, the sums specified out of any money directed to be applied as Appropriations in Aid under Article 206(1)(b) of the Constitution.

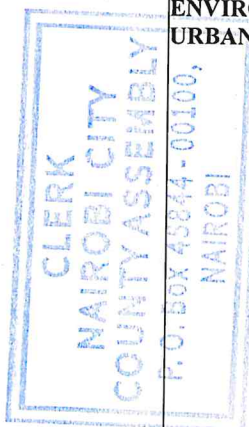

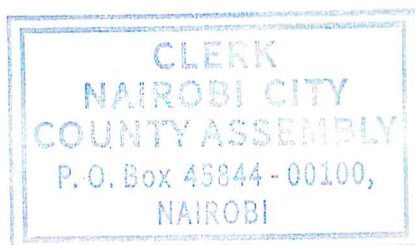
