

THE NAIROBI CITY COUNTY SUPPLEMENTARY APPROPRIATION ACT, 2014

No. 4 of 2014

Date of Assent: 15th May, 2014

Date of Commencement: 19th May, 2014

AN ACT of Nairobi City County Assembly to authorize the issue of a sum of money out of the County Exchequer Account and its application towards the service of the year ending on the 30th June, 2014 and to appropriate that sum and a sum voted on account by the Nairobi City County Assembly for certain public services and purposes

ENACTED by the County Assembly of Nairobi City as follows-

1. This Act may be cited as the Nairobi City County Short title. Supplementary Appropriation Act, 2014.

- 2. (1) The County Treasury may issue out of the Issue of Kshs. County Exchequer Account and apply towards the supply granted for the service of the year ending on the 30th June, 2014, the sum of Kenya Shillings 22,362,598,601 (twenty two Billion, three hundred sixty two million, five hundred appropriation of the ninety eight thousand six hundred and one) and that sum shall be deemed to have been appropriated as from 1st July, 2013, for the services and purposes specified in the Schedule annexed hereto.
- (2) The sum granted out of the County Exchequer Account by subsection (1) as authorized by the Nairobi City County Assembly on the 2nd April, 2014, in accordance with Article 224 of the Constitution.
