

## NAIROBI CITY COUNTY FINANCE ACT 2019BI

#### No. 8 of 2015

Date of Assent: 20th November, 2015.

Date of Commencement: See Section 1

AN ACT of the Nairobi City County Assembly to amend County legislation relating to taxes, fees and charges for services, and for other revenue raising measures by the county government; and for matters incidental thereto

ENACTED by the Nairobi City County Assembly as follows-

## PART I—PRELIMINARY

1. This Act may be cited as the Nairobi City County Short title and Finance Act, 2015 and shall come into operation on such a date as the County Executive Committee Member for Finance, with the concurrence of the Governor, may appoint and different dates may be appointed for different provisions.

Commencement.

2. The Nairobi City County Finance Act, 2013, is hereinafter referred to as the Finance Act, 2013, is amended by-

Amendment of the short title, etc of the Nairobi City County Finance Act, 2013.

- (a) deleting the Short Title thereto and substituting therefor the following new Short title-
- "the Nairobi City County Revenue Act, 2015."
- (b) adjusting the Long Title to accord with the new Short Title.
- (c) The Finance Act, 2013 is amended in the Schedule thereof in the manner set out in the Schedule herein.




