

# THE NAIROBI CITY COUNTY SUPPLEMENTARY APPROPRIATION ACT, 2015


AN ACT of Nairobi City County Assembly to authorize the issue of a sum of money out of the County Revenue Fund and its application towards the service of the year ending on the 30th June, 2015 and to appropriate that sum and a sum voted on account by the Nairobi City County Assembly for certain public services and purposes

ENACTED by the Nairobi City County Assembly, as follows-

#### PART I-PRELIMINARY

- This Act may be cited as the Nairobi City County Short title Supplementary Appropriation Act, 2015.
- 2. (1) The County Treasury may issue out of the County Revenue Fund and apply towards the supply granted for the service of the year ending on the 30th June 2015 the sum of Kenya Shillings Twenty five billion five hundred eighty eight million, eight hundred thirty three thousand, four hundred and forty three and that sum shall be deemed to have been appropriated as from 1st July, 2014, for the services and purposes specified in the schedule annexed hereto.

(2) The sum granted out of the County Revenue Fund by sub-section (1) as authorized by the Nairobi City County Assembly on the 30th April, 2015, in accordance with Article 224 of the Constitution. Issue of KSh. 25, 588,833,443 out of the County Revenue Fund for Public services and for purposes of the year ending 30th June, 2015 and Appropriation of the money granted.
