2.0. INTRODUCTION

The Committee met at the Nairobi West Sub-County offices, and was welcomed by Mr. Gilbert Odira, Chairman, Sub-County Alcoholic Drinks Control and Licensing Committee.

2.1. COMMITTEE OBSERVATIONS

During the site visit undertaken on Monday 22nd February, 2016, the Committee made several observations and was briefed by members of the Sub-County Committee as follows;

- Nairobi West Ward has a total of thirty three (33) modern kiosks selling alcoholic drinks.
- Following the criteria set by The Nairobi City County Alcoholic Drinks Control and Licensing Act, 2014, twenty one (21) modern kiosks dealing with alcohol in Nairobi West shopping centre are in contravention of;
 - The Public Health Act there is inadequate space, no provision for sanitary facilities, or running water. These requirements are mandatory when providing liquor licenses; and
 - ii. The Urban and Physical Planning Act the kiosks are built on spaces created for the purpose of pedestrian footpaths and road reserve areas; hence the kiosks do not qualify to operate liquor businesses or any other business.
- 3. At the time of the visit, the Sub-County Alcoholic Drinks Control and Licensing Committee had issued notices of closure to the said 21 kiosks, i.e. twenty one (21) days' notice to clear their stock and thereafter stop the sale of liquor in their premises.
- 4. The owners of the kiosks appealed to the Nairobi City County Liquor Board and pleaded with the County Government to provide facilities like toilets and water.
- 5. Some kiosks go to an extent of selling alcoholic drinks on verandahs, corridors and road reserves.



- Other kiosks owned by senior police officers are in operation though they have not been licensed nor applied for the same.
- All kiosks in Discount Mall, Nairobi West Shopping Centre, selling alcoholic drinks lack;
 - i. Running water
 - ii. Sanitary facilities
 - iii. Adequate space

)

- iv. Hand washing facilities
- 8. Several kiosks sell shisha which it is not dealt with by The Nairobi City County Alcoholic Drinks Control and Licensing Act, 2014.
- In Osidai Plaza, Nairobi West Shopping Centre, two kiosks namely; Tiwas Wines & Spirits and Trimes Liquors Store have legal licenses yet they were not approved by the Sub-County Committee.
- 10. At the time of the visit, most of the kiosks selling alcohol were closed as they only operate from 5.00 p.m to 11.00 p.m. However some unscrupulous traders had opened but hurriedly fled after seeing the liquor licensing department enforcement officers.
- 11. Some wholesalers selling/supplying alcohol drinks to kiosks in Discount Mall are not licensed e.g. Jumbo Agencies in Kayole. Ms. Peninah Sang from the Nairobi City County Liquor Licensing Department confirmed that Jumbo Agencies in Kayole is not a licensed distributor of alcoholic drinks.

SUBMISSIONS BY THE NAIROBI WEST SUB-COUNTY ALCOHOLIC DRINKS CONTROL AND LICENSING COMMITTEE

The Committee was experiencing several challenges which include;

- 1. Lack of enforcement unit to ensure that all traders selling alcohol comply with the Nairobi City County Alcoholic Drinks Control and Licensing Act, 2014.
- Lack of cooperation from the Trade, Tourism and Cooperatives Department, especially the licensing sector. Upon rejection of some liquor licensing applications pursuant to Section 9 (1) of the Nairobi City County Alcoholic Drinks Control and

Licensing Act 2014, the Committee purported that the liquor licensing sector granted licenses to the same applicants.

3.0 CONCLUSION

Alcohol and drugs abuse has permeated all strata of Kenyan society, with the youth and young adults being the most affected groups. The hazardous and harmful use of alcohol is locally and internationally gaining recognition as a major risk factor for noncommunicable diseases, disability and mortality caused by accidents, violence and crime. The harmful use of alcohol results in approximately 2.5 million deaths each year. Apart from such health consequences, excessive alcohol consumption has also been linked with various negative social and economic outcomes. Its economic impacts manifest at both the macro and micro level as countries incur the financial costs of responding to the negative health and social consequences (World Health Organization, 2011).

4.0 RECOMMENDATIONS

Following the site visit to Nairobi West Ward, the Committee recommends that this Assembly resolve as follows;

- 1. That all kiosks which do not meet the required operating standards including sanitary facilities should stop the sale of liquor and the owners transfer to other premises that meets the standards;
- 2. That all unlicensed modern kiosks selling liquor should be closed down;
- 3. That the right procedure of liquor licensing should be strictly followed as provided by the Nairobi City County Alcoholic Drinks Control and Licensing Act, 2014 and penalties enforced on all business premises faulting the provisions;
- 4. The Licensing Department should encourage off licenses (no consuming on site) as provided in the third schedule of the Nairobi City County Alcoholic Drinks Control and Licensing Act, 2014;
- 5. Cordial working relations between

guarantee implementation of the Nairobi City County Alcoholic Drinks Control and Licensing Act, 2014;

- 6. The Licensing Department should consider introducing a licensing window period to reduce the never-ending irregularities in licensing process;
- 7. The enforcement section should establish measures that would permanently bar unlicensed retailers and wholesalers from selling liquor; and
- 8. The Nairobi City County Alcoholic Drinks Control and Licensing Act, 2014, should be reviewed to incorporate other narcotic drugs and shisha;
