2.1 DAY 1 OF THE WORKSHOP

2.1.1 Opening remarks by the Chairperson

The Workshop was officially opened by the Chairperson. He led the meeting through a round of introductions and subsequently, took the Committee through the key issues that would be covered in the workshop and encouraged the Members to sit through in order to have proper engagement. He welcomed and thanked the participants for availing themselves for the workshop and introductions were made. The Chairman wished the Committee fruitful deliberations ahead of the workshop.

2.1.2 Introduction

On 12th October 2018, the Committee purposed to dispense with pending business before it. Of importance, was the Committee's report on its site inspection visit to various projects in the County to assess their status ahead of the payment that the County had committed to settle for the contractors who had raised certificates.

2.2 PRESENTATION

2.2.1 Site inspection visit draft report

The Committee was led through the draft findings by the Clerk Assistant who then stated that purpose of the discussions was for the Members to confirm the veracity of the findings and observations.

The Committee was informed that during the seven day visit, Members of the Committee visited 32 projects in the following Wards and projects:

2.2.2 Key observations

The Committee was informed that, while conducting the site inspection visits, the following salient issues were of note:

- 1. That some of the projects had stalled due to delayed payment from the County after the contractors raised certificates;
- 2. That the quality of the road construction materials used by the various contactors may not have been up to the required standards going by what the Committee witnessed at Access Road to HACCO industries;
- 3. Some contractors had abandoned their sites for good despite of payment of their certificates;
- 4. Some projects, for instance, Lumumba Drive and box culvert across Gathara Ini River had been properly done and complete despite delayed payments;
- 5. There was extreme encroachment on public transport infrastructure, especially on walk ways and drainage systems by traders, mechanics and broken down vehicles; and
- 6. The Committee observed poor workmanship on selected projects, for instance, St. Martin Catholic Church in Huruma Ward, where the road was grossly uneven and poorly done drainage system. The road was already developing potholes.

2.1.3 Recommendations

In view of the findings and observations, the Committee proposed the following recommendations in its report:

i. The County to liaise with the National Government Ministry of Transport and Infrastructure in view of developing and gazetting quality of works guidelines and require that contractors meticulously adhere to the standards of construction materials and quality of workmanship. Upon rolling out, this is

meant to ensure that the County gets value for money and residents gets lasting infrastructure;

- ii. The Finance and Economic Department to review its processes in view of ensuring that certificates are paid for soon as they are raised by contractors. This is expected to curb the rate at which contractor abandon sites mid-way subjecting projects to premature wear and tear. Further, this will mitigate the challenge of rolling over of projects to new financial years;
- iii. The County Inspectorate and Enforcement Department to cooperate with contractor working on County roads or separately in view of ensuring that way leaves (drainage and walk ways) are kept clear of encroachment by traders; illegal garages and parking of broken down vehicles. Upon enforcing this, the public transport infrastructure will be safeguarded and put to use as intended;
- iv. The Department of Public Works, Roads and Transport to review the engagement with contractors who have failed to deliver quality transport infrastructure and those who have refused to resume works after payment of certificates is done. For instance, the Mwiki- Githurai motorable bridge, Tarmacking of Stadium Road in Makongeni Ward and tarmacking of Upendo Road in Hospital Ward have stalled despite the Sector reporting that their first certificates had been settled;
- v. Administrative action be taken against project supervision engineers (resident engineers) whom projects under their supervision do not adhere to the Bills of Quantities upon overall summative assessment before hand over; and
- vi. The Committee to liaise with the County Department on Public Works, Roads and Transport in a bid to have a Public Transport infrastructure and Spaces regulatory, protection and Control Bill to have public transport infrastructure kept secure from vandalism, encroachment and damage and ensure that they are properly utilized.

3.1 DAY 2 OF THE WORKSHOP

3.1.1 Introduction

On 13th October 2018, the Committee held a meeting with Eng. Bob Ariemba, the Ag. Director for Roads from the County Executive Department of Public Works, Roads and Transport regarding progress made in implementation of FY 2017/2018 budget, 1st Quarter of FY 2018/2019 and implementation of the Nairobi City County Non-Motorized Transport Policy.

The Committee was informed that during the planning stage, the Sector and the Committee were in agreement that incomplete works from the previous Financial Years were to be prioritized hence many of the projects are ongoing due to the same reason.

Further, the Committee was informed that many of the projects from the previous years were being carried forward due to cash flow challenges and many of them are ongoing with some contracts terminated or ongoing.

The Committee was concerned that if the Sector failed to ensure that the ongoing projects are noted completed in the current financial year, the same would once again roll over to the next Financial Year impeding the Sector from embarking on new projects.

3.2.2 Nairobi Regeneration Programme

The Committee was informed that Nairobi Regeneration Programme is a partnership entered into between the National Government under KURA and Nairobi City County Government.

The purpose of the partnership is to ensure improvement of roads in Eastlands area owing to the fact that the region road infrastructure was deteriorated. The projects were divided into three lots.

In this partnership that was worth Ksh. 2.7 billion, the County Government was expected to contribute 1/3rd (Ksh. 900,000) of the budget and the rest, National Government.

The Committee commended the initiative because some improvement has been ongoing in the various Wards in Eastlands. However, the Committee noted that the report was lacking the current status. However, the Sector informed the Members that the Sector has not been receiving status reports from KURA since much of the works are being undertaken through the agency.

4.1 OVERVIEW OF THE NAIROBI CITY COUNTY NON- MOTORIZED POLICY

4.1.2 Introduction

The Committee was informed that being the oldest mode of transport, non-motorized mode of transport is non-polluting mode that requires little infrastructure and integral to the health of individuals. The policy was formulated and passed by the Assembly during the First Assembly and is being effected by the County.

4.1.3 Overview of the policy

The policy has a vision to have Nairobi be a County where NMT is the mode of choice for short and medium trips.

Its objectives are to:

- Increase mobility and accessibility;
- Increase transport safety;
- Improve amenities for NMT;
- Ensure that adequate funding/investment is set-aside for NMT infrastructure (20% of RPWT budget)

Generally, the Committee was informed that the policy proposes an integrated and allinclusive transport system in which NMT users are provided with appropriate spaces and facilities to enjoy their freedom of safe movement, which is a fundamental human right.

4.1.4Situational analysis

The Committee noted that the existing transport infrastructure is basically road based and mostly oriented to car use. Therefore, the infrastructure required by the NMT users is either lacking, encroached or inadequate.

The safety of pedestrians should therefore be a major concern given that about 70% of accidents in the City involves pedestrians. Some of the concerns accessibility oriented and include: lack of parking and transfer facilities for bicycles at many destinations and the gradient of most footbridges is often too steep and do not allow continuity of movement.

Further, there is discomfort in usage of pedestrian and cyclist facilities are not properly maintained given that those that are tarmacked are often riddled with potholes and stagnant water.

4.1.5 Proposed steps going forward

The Committee was informed the County aims at ensuring that the following are in place for effective NMT integration:

- Developing a Nairobi Streets and Roads Design Manual (NSRDM) to guide planning, design and management of all transport facilities and amenities within the County, in line with the adapted "Complete Streets" principles.
- Reviewing of existing by-laws to enhance safety of NMT users as they are "vulnerable users" so that they can be protected.
- Ensuring the provision of NMT on the frontage of all commercial developments
- Developing comprehensive data base for NMT users and facilities regular NMT surveys (behaviour, socio-economic status, gender, volumes, trip rates and purposes,
- Developing and rolling-out basic NMT education and awareness programmes for local neighbourhoods, schools etc
- Setting up of steering committee to oversee the implementation of the policy
- Developing incentives for organisations and business that encourage NMT usage
- Integrating land use patterns with:
- A description of public input used to develop implement the NMT Plan
- Estimated number of existing and future NMT commuters
- Existing and proposed NMT facilities
- Existing and proposed multi-modal connections
- Project descriptions and priority listings
- Developing guidelines for:
- Road side activities
- During and after trenching on NMT wayleaves
- NMT management during road construction
- Signage
- Developing a feedback and use evaluation mechanisms (monitoring and evaluation tools)

- Coming up with an implementation action plan and committee
- Securing funding for NMT for effective implementation of the policy.

4.2 NMT projects in the City

The Committee was informed that in line with the policy, the County has rolled out the following projects that are at various stages of execution:

- 1. Construction of NMT facilities along Baba Dogo Road that is 40% complete;
- 2. Construction of NMT along Muindi Mbingu Street which has just started;
- Construction of NMT on selected roads in the CBD(Race Course Road and Aga Khan Walk);
- 4. Construction of NMT and Public Transport facilities along Ojijo Road that is 30% complete; and
- 5. Construction of NMT facilities along Mathare 4A-Thika Road which has just started.

The Committee raised concern that the rolling out of the policy is taking longer than expected since it was passed during the First Assembly.

5.1 CLOSING OF WORKSHOP

5.1.1 Way Forward

- 1. The Committee to adopt its report on site inspection visits for Tabling in the Assembly;
- 2. The Committee to conduct site inspection visits to selected projects assess progress made against report given by the Sector;
- 3. The Committee to seek audience with the Cabinet Secretary of Infrastructure and Transport regarding projects being implemented by KURA and KERRA;
- 4. The Committee to seek audience with the County Secretary and H.E the Governor regarding rampant delay in payment of contractors who work for the County and inadequate and defective road maintenance and construction equipment;
- 5. The Committee to collaborate with the Sector in order to come up with the Nairobi City County Non-Motorized Transport Bill;
- 6. The County Department on Public Works, Roads and Transport to liaise with the counterpart Department on Finance and Economic Planning in a bid to expedite payments. This is expected to ensure that contractors working on various projects complete them in time to avoid rolling them over to the subsequent Financial Year again; and

7. The Sector to implement the recommendations of the Committee on ongoing projects in 2.1.3 above.

5.1.2 Chairman's concluding Remarks

On behalf of the Committee, the Chairman thanked the Eng. Bob Ariemba, who had been assigned to attend the retreat in order to assist the Committee deliberate on crucial oversight matters and find way forward on arising concerns. He also expressed gratitude to the Members and Staff of the Committee for ensuring that the retreat had been conducted in a manner that was deliberating and amicable. He finally wished all the participants safe journey back and he declared the retreat officially closed.
